In continuation to our intimation vide reference cited, in terms of Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to submit the following:

- *In the matter of disposal of fertiliser plant of NLCIL to M/s Metro Machinery Traders, the Hon'ble Sole Arbitrator awarded a sum of Rs. 1,25,49,96,511/- with interest @ 12% P.A w.e.f. 01.09.2006 till the date of award i.e 14.12.2016, with cost of Rs.10,00,000/- and the award shall carry interest@ 18% per annum from the date of the award till payment.*
- *Aggrieved by the said award, NLCIL filed an application U/s 34 of A & C Act, before the District Court, Cuddalore in OP No. 29 of 2017, which was dismissed on 07.02.2020. As against the said order, NLCIL filed CMA No. 1797 of 2020 before the Hon'ble Madras High Court.*
- *The Hon'ble Division Bench of Madras High Court after hearing both sides pronounced Orders to set aside the impugned Award dated 16.12.2016, also the order dated 07.02.2020 passed by PDJ, Cuddalore and accordingly allowed the CMA No. 1797 of 2020 filed by NLCIL.*
