The adoption of the standard did not have any material impact to the financial results for the current period.  
 (5) During the previous year, the Company acquired the control of Godrej Tyres Private Limited and Godrej Maxxim Private Limited and the income statement will reflect from March 27, 2019. Accordingly, consolidated financial results of the current quarter include the financial results of the current quarter results of Godrej Tyres Private Limited and Godrej Maxxim Private Limited as subsidiaries. Hence, the consolidated financial results of the current quarter are not comparable with the financial results of the previous periods.
