LOOKING TO ENTER INDIA AUTO MARKET

Mobileye to provide driver assistance tech to M&M

ED LUDLOW Bengaluru, January 9

MOBILEYE GLOBAL WILL supply advanced driver assistance technology for Mahindra & Mahindra's next-generation vehicles, as it eyes growth in India's auto market. The companies will also work together on a fully autonomous driving system for India, Mobileye said in a statement Tuesday at the Consumer Electronics Show in Las Vegas. Financial terms weren't disclosed. Jerusalem, Israel-based Mobileye makes chips and systems for advanced driver assistance technology in cars and lower levels of autonomous driving. The company is Israel's most valuable publicly-traded company by market capitalisation.

THE ROAD AHEAD

India's notoriously dangerous roads could become safer with advanced driver assistance technology. The country has the world's deadliest roads, with crashes killing and disabling over 900,000 people every year, according to the World Bank. Advanced driver assistance technology however isn't widely adopted the country's

and is largely limited to premium cars, putting it out of reach for the country's price-sensitive buyers. Mahindra, one of the biggest SUV makers in India, first introduced Mobileye driver assistance features on the XUV700 SUV in 2021. Tata Motors is the only other domestic carmaker that sells vehicles with the technology in the market. Mobileye's shares dropped to the lowest on January 4 after the company gave a sales outlook for 2024 significantly below Wall Street expectations. Mobileye also forecast a decline in sales of 50% year-on-year in the current first quarter as customers and automakers work through a backlog of ADAS chips and have stopped placing orders. —BLOOMBERG

BluSmart shifts gears, starts surge pricing

GURUGRAM-BASED ALL-ELECTRIC TAXI startup BluSmart has announced that it will introduce a new pricing structure, marking out 'rush hour' parts of a day when fares will be slightly higher, and the remaining part of the day, 'leaked hour', when fares will be regular or reduced. This is a significant shift for the company, which has long prided itself on its no-surge pricing policy. Rush hours will be 8:30 am to 10:30 am and 5:30 pm to 8:00 pm for city roads, 3:30 am to 6:30 am for city-to-airport roads and 9:00 pm to 1:00 am for airport-to-city roads. While 'rush hour' will be applicable only on weekdays for city roads, it will be applicable on all days for airport roads. BluSmart says that the introduction of a new pricing structure is intended to

improve ride availability and reliability during peak hours. The company reasoned that during these times, there is often an increased demand for cabs, which can lead to longer trip durations. By slightly adjusting the fares for these hours, BluSmart hopes to

incentivise more drivers to be on the road, which will improve service experience for all riders. "This change is a strategic move to align with industry benchmarks," said Anirudh Arun, co-founder and CEO, BluSmart, in a statement. It remains to be seen how riders and drivers respond to the new pricing structure. Uber, Ola and Rapido have been following a surge pricing model for a few years now. Responding to criticism on moving away from its longstanding no-surge promise, co-founder of BluSmart, Anmol Singh Jaggi, wrote on X: "Surge price is unpredictable, our pricing is just a true and transparent reflection of effort by driver partners during rush hours. Surge is non-transparent & arbitrary, what @BluSmartIndia has done is to make it clear & upfront on what the pricing would be"

Swiggy, Instamart VP quits

FOOD DELIVERY GIANT Swiggy has seen another high-profile exit as Sidharth Satpathy, vice president of Swiggy Instamart, stepped down after four years with the company. Satpathy's departure follows a string of senior resignations at Swiggy in recent months amid preparations for its much-anticipated IPO. Satpathy announced his move on LinkedIn, praising his colleagues and expressing gratitude for his time at Swiggy. He will be replaced by Anirudh Roy, former performance marketing head at Amazon India.

New execs at LTIMindtree & Accenture

LTIMINDTREE HAS APPOINTED former senior executive of Amazon Web Services (AWS), Shuchi Sarkar, as its chief marketing officer. Sarkar succeeded Parsh Vankar, who resigned in October last year. Sarkar was the global head of marketing — segments at AWS, just before joining the Indian IT firm. In a recent high-level appointment, Accenture has appointed former Infosys senior executive Binny Mathews as its new chief procurement officer and head of the company's Procurement Plus capability. —FE BUREAU

Airtel Business to power 20 mn smart meters for Adani Energy

BHARTI AIRTEL ON Tuesday said its enterprise arm Airtel Business will provide real-time connectivity and smart internet-of-things (IoT) solutions for 20 million smart meters of Adani Energy Solutions. Adani Energy Solutions has an order book of smart meters from the power utilities of Assam, Andhra Pradesh, Bihar, Maharashtra and Uttarakhnad. Airtel's smart metering solutions, powered by narrowband IoT, 4G and 2G, will help Adani Energy ensure real-time connectivity and uninterrupted transfer of critical data between smart meters and head-end applications. Narrowband-IoT (NB-IoT) is a low-power area technology that enables a wide range of new IoT devices and services, and ensures low power consumption. Such technology is crucial for smart meters. The solution will also come powered with Airtel's IoT platform, 'Airtel IoT', which enables real-time meter tracking and monitoring with advanced analytics and diagnostic capabilities required to control energy consumption, the CEO said in a statement. "Airtel expects its NB-IoT technology to play a significant role in the utilities space to connect and manage smart meters at scale with enhanced coverage, high reliability and security," said Ganesha Lakshminarayana, CEO of Airtel Business, India.

Carlyle taking 'keen interest' in SpiceJet

AHEAD OF SPICEJET'S AGM (annual general meeting) — scheduled on Wednesday — to raise ₹2,50 crore, global aircraft lessor Carlyle Aviation Partners has taken a "keen interest in both SpiceJet and SpiceExpress," sources told FE. According to sources, Robert Korn, president of Carlyle Aviation Partners, travelled to India on Monday to meet SpiceJet chairman Ajay Singh to discuss partnership for the airline. These include augmenting the fleet size at a time when the industry is facing a supply crunch. The aircraft lessor is the commercial aviation investment and servicing arm of Carlyle's \$14.3 billion global credit platform. Carlyle recently acquired a 7.03% stake in SpiceJet. The domestic carrier's fundraise plans and move to strengthen its market share, which stood at 6.2% in November, come at a time when supply chain issues have resulted in around 80 planes of Indian carriers being grounded. "SpiceJet's fund infusion provides the airline with a rare opportunity to scale up its market share by getting its 25 grounded planes back in the air," sources said. On Wednesday, SpiceJet shareholders will vote on a revival plan that intends to raise up to ₹2,250 crore through various avenues.
