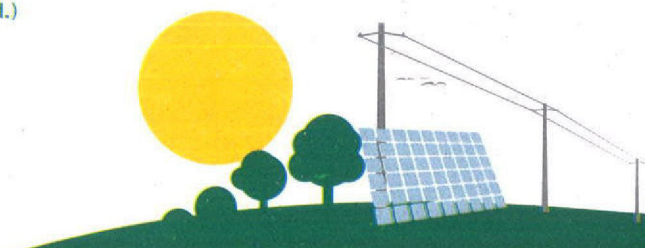

Taiwan holds drills amid Pelosi visit concern, China tension

AGENCIES Beijing

Taiwan's capital staged air raid drills on Monday and its military mobilised for routine defence exercises, coinciding with concerns over a forceful Chinese response to a possible visit to the island by US Speaker of the House Nancy Pelosi.

While there was no direct link between China's renewed threats and Taiwan's defensive moves, they underscore the possibility of a renewed crisis in the Taiwan Strait, considered a potential hotspot for conflict that could envelop the entire region.

Air raid sirens were sounded in the capital Taipei and the military was holding its annual multi-day Han

Kuang drills, including joint air and sea exercises and the mobilization of tanks and troops.

In Taipei, police directed people to shelters when a siren went off shortly after lunchtime. Streets emptied and shops closed.

"In recent years, Chinese military planes have frequently harassed Taiwan,

and the war between Russia and Ukraine broke out in February this year," Taipei Mayor Ko Wen-je told reporters, referencing concerns that a similar conflict could break out in East Asia. "All these things make us understand the importance of being vigilant in times of peace and we need to be prepared if there is war."

Sri Lankan Presidential Secretariat back in action

Sri Lanka's Presidential Secretariat, which was stormed by a sea of anti-government protesters in early July, resumed operation from Monday amidst tight security.

The building's entry gate has been blocked by the protesters since April 9. On July 9, the protesters stormed the building and occupied it. In the early hours of Friday last, police and security forces conducted a raid and took back control of the building from the protesters on the order of the crisis-hit island nation's new President Ranil Wickremesinghe.

The Secretariat resumed operations under a tight security cover, they said.

3 arrested while selling items stolen from President's House

Three people have been arrested by the Sri Lankan police as they were trying to sell 40 gold-plated brass sockets stolen from the President's House here after angry demonstrators stormed the iconic building during an unprecedented anti-

government protest. The Welikada police arrested the suspects while attempting to sell the stolen items on Sunday, it said. The arrested suspects, aged 28, 34 and 37, are residents of Obeyesekerepura in Rajagiriyva. Police said the three were also suspected drug addicts.

Complaint filed against Gotabaya in Singapore for 'war crimes'

A South Africa-based rights group has submitted a criminal complaint to the Attorney General of Singapore requesting the arrest of the former Sri Lankan President, Gotabaya Rajapaksa, for alleged war crimes.

Lawyers from International Truth and Justice Project (ITJP) submitted a 63-page complaint that argues that Rajapaksa committed grave breaches of Geneva Conventions in civil war in 2009 when he was defence secretary and these are crimes subject to domestic prosecution in Singapore under universal jurisdiction.

The legal complaint states that Gotabaya Rajapaksa committed violations of international humanitarian law and international criminal law during the civil war in Sri Lanka.

Musk denies affair with Google co-founder Sergey Brin's wife

Tesla CEO Elon Musk on Monday denied that he had a brief affair with Google co-founder Sergey Brin's wife Nicole Shanahan that allegedly led to their divorce earlier this year, saying there was nothing "romantic" with Shanahan.

A Wall Street Journal report claimed on Sunday that Musk engaged in a brief affair last fall with the wife of Sergey Brin, prompting the Google co-founder to file for divorce earlier this year and ending the tech billionaire's long friendship.

In a tweet, Musk said: "This is total bs. Sergey and I are friends and were at a party together last night!"

"I've only seen Nicole twice in three years, both times with many other people around. Nothing romantic," the Tesla CEO added.

According to the report, the Musk and Shanahan's affair allegedly occurred at the 'Art Basel' event in Miami following the Tesla CEO's split with then-girlfriend Claire Boucher, famously known as Grimes. Brin and Shanahan were separated but still living together at the time.

Chinese astronauts enter lab module in orbit

Three Chinese astronauts aboard the country's space station, currently under construction, successfully entered the lab module in orbit for the first time on Monday, a day after the space laboratory was launched, according to the China Manned Space Agency.

China launched its space laboratory called Wentian on Sunday, sending the country's largest-ever spacecraft into Earth's orbit to become part of the space station named Tiangong, which is currently under construction.



20-tonne-level spacecraft conducted rendezvous and docking in orbit, and also the first time that space rendezvous and docking were carried out during the astronauts' in-orbit stay in the space station, the China Manned Space Agency (CMSA) told official media. After the docking, the three astronauts who were building the space station entered the lab, Xinhua news agency reported. It was the first time the Chinese astronauts had entered the lab module in orbit.

BATTLING COVID

Shenzhen seals off 100 big firms including Foxconn

The Shenzhen government asked 100 major companies, including iPhone maker Foxconn and oil producer CNOOC Ltd, to implement a "closed loop" system for a week as the southern city battles a Covid outbreak.

Bloomberg News reported on Monday Foxconn said that operations at its Shenzhen facilities were "normal" and that it would follow government guidelines to ensure safe production.

The city government asked companies including BYD Co, Huawei Technologies Co, and ZTE Corp, to restrict operations only to employees living within a closed loop, with little to no contact with people beyond their plants or offices, the report said, citing a Shenzhen government notice.

The Shenzhen government, Huawei and CNOOC did not immediately respond to request for comment.

World leaders congratulate Prez Murmu

Several world leaders, including presidents of China, Russia, Sri Lanka and Nepal, have congratulated India's new president Droupadi Murmu who assumed office on Monday.

Chinese President Xi Jinping on Monday congratulated Murmu, 64, on assuming office, saying he stands ready to work with her to enhance political mutual trust, deepen practical cooperation and properly handle differences.

Russian President Vladimir Putin also congratulated Murmu and expressed hope that she will further promote bilateral productive cooperation.

गोपाल, (निप्र)। मप्र में किराएदार मकान पर कब्जा नहीं कर सकेगा। मकान मालिक भी किराएदार को तंग नहीं करेगा। इसके लिए मध्य प्रदेश सरकार विधानसभा के मानसून सत्र में मध्य प्रदेश किराएदारी अधिनियम प्रस्तुत करेगी। इसके लागू होने के बाद मकान मालिक बिना अनुबंध के किराएदार नहीं रख पाएंगी। प्रदेश में मकान मालिक और किराएदार के बीच होने वाले विवाद को समाप्त करने के लिए सरकार किराएदारी अधिनियम लागू करने जा रही है। इसके बाद मकान मालिक अनुबंध कर ही किराएदार रख सकेगा। इसके तहत किराया अधिकरण बनेगा। जिसमें किराया प्राधिकारी नियुक्त होगा। मकान मालिक को किराएदार की जानकारी दो महीने के अंदर अंदर किराया प्राधिकारी को देनी होगी। इसके बाद निर्धारित अवधि के बाद किराएदार को मकान खारी करना होगा। ऐसा नहीं करने पर शिकायत पर

सुनवाई के बाद बेदखली की कार्रवाई की जाएगी। इसमें मकान मालिक भी किराएदार को अनावश्यक रूप से तंग नहीं कर सकेगा। वहीं, आवश्यक सेवाओं को रोके पर भी मकान मालिक के खिलाफ कार्रवाई होगी। केन्द्र सरकार ने भूस्वामी और किराएदार के अधिकारों के संरक्षण के लिए सभी राज्यों को कानूनी प्रविधान करने के लिए दिशानिर्देश दिए थे। नगरीय विकास एवं आवास विभाग ने मया मध्य प्रदेश किराएदारी अधिनियम का प्रारूप तैयार किया है। इसके अनुसार किराया अधिकरण बनाया जाएगा। जिसे किराएदार के साथ अनुबंध की दो महीने में जानकारी देनी होगी। मकान मालिक और किराएदार के बीच शिकायत की सुनवाई भी किराया अधिकरण में होगी। मकान मालिक मकान के लिए दो महीने और गैर आवश्यक भूखंड के लिए छह माह का अग्रिम ले सकेगा।
