Pandemic uncertainties make destination weddings intimate/private affair

Many destination weddings are now taking place with just 50-60 guests, as hosts seek to cut Covid-19 risks, serve a more luxurious experience.

Ahmedabad

Uncertainties associated with the Covid-19 pandemic, coupled with an opportunity to serve a richer experience guests, have resulted in destination weddings becoming smaller and a much more intimate/private affair, according to wedding planners.

destination wedding industry was hit hard by the pandemic as weddings fell to a trickle for the most part of 2020 and several months in 2021 because of the first and second waves of the pandemic. Destination weddings have resumed the past few months with the pandemic situation easing, but are still below the 2019 levels, and many have also got much smaller.

"Before pandemic, destination wedding would mean at least guests. 250-300 A majority of the weddings still have that many or even more guests, but of late, we are also seeing

The minimum cost of a destination wedding is estimated at around Rs. 2-3 crore, and even though weddings may have become smaller, the expenses remain around the same levels.

"Many clients are in the "You live only once" mode and are not shying away from spending. With guests, fewer are booking better hotels and facilities and providing a much more luxurious and personalised stay and experience. Some weddings have smaller in size, but they have gotten bigger and grander in terms of the overall experience," said Sarvaiya. Moreover, higher

tariffs, with hotels in popular wedding destinations asking for one-and-a-half times pre-pandemic rates due to a sudden revival in demand, besides higher decoration, logistics, and food costs, have contributed to

an increase in the expenses incurred for destination weddings. "Hotel tariffs had

gone through the roof as demand surged, but they have come down again in the past fortnight or so as many weddings and other large events have been put on hold because of the Omicron variant and the increase in Covid-19 cases. We are hoping that the pandemic situation stabilises quickly so that the wedding planning industry can continue its revival," added Sarvaiva.
