Sub: INTERIM STAY by Hon'ble National Company Law Tribunal, Hyderabad in the matter of M/s.Liquors India Limited, Hyderabad - reg.

Pursuant to Regulation 30 of the SEBI (Listing Obligation and Disclosure Requirements), Regulations, 2015 ("Listing Regulations"), we hereby inform that in the on-going legal disputes with Mr.Anil Agrawal, his Comfort group of companies and others, on siphoning of Company's IPO funds, illegal take-over of M/s. Liquors India Limited from the Company and other matters, Hon'ble National Company Law Tribunal, Hyderabad, in the matter of M/s.Liquors India Limited, in CP.No.5/111/CB/2013 (TP.No.148/HDB.2016), on 17.01.2023 has ordered "STATUS QUO", as on date, as regards the resolution passed in the Board Meeting of Comfort Intech Limited (Scrip Code: COMFINTE | 531216 | INE819A01031) held on 09.01.2023 till next hearing, with the following observation:

*"A perusal of the annexure-1 to the letter dated 10.01.2023 discloses that at column no.9, the current shareholding of the Respondent Company is shown as 47.96% and the post-acquisition stake of the Respondent Company in Liquor India Limited will not exceed 67%. However, it is not mentioned that the said claim of shareholding of 47.96% is the sub-judice. Thus, there appears to be non-disclosure of the present proceedings in the declaration filed by the 1st Respondent before the BSE.*
