Mumbai, May 30 (UNI) : The India Meteorological Department (IMD) said on Thursday that the monsoon will arrive in the city and across the state in

eight to 10 days after the southwest monsoon hits Kerala within the next 24

hours.Director of the IMD in Mumbai Sunil Kamble said that the IMD is expecting the arrival of the monsoon in Kerala one day in advance of its usual date of June 1.

"The normal date of the onset of monsoon in

Kerala is June 1. But we are expecting an advanced monsoon, and within 24 hours, we are expecting the monsoon to reach Kerala. Once the monsoon arrives in Kerala, it takes eight to ten days to cover Maharashtra," Kamble said.

Three tourists drown in backwaters of irrigation dam in Kolhapur

Kolhapur, May 30 (UNI) In a tragic incident, three tourists, including two women, drowned in the backwaters of irrigation dam at Olvan-Bhatwadi area in Radhanagari tehsil of this district on Thursday. According to Radhanagari police, three tourists went to take bath in backwaters and while taking bath, all of them drowned following not able to judge properly the deep of the water. The deceased decided to take meal at the bank of backwaters at Olvan-Bhatwadi village and told the relatives to bring meal. When their relatives came with tge meal, they saw the bodies floating on the water. After receiving information, Radhanagari police immediately rushed to the spot and fished out the bodies with the help of local villagers. Police identified the deceased as Satish Laxman Tipugade (26), Ashiwini Rajendra Malvekar (32) and her daughter Pratiksha (13), all from Kagal tehsil in this district. Radhanagari police inspector Santosh Gore investigating the matter further.

INDIA bloc will form government, PM will be elected unanimously: Kharge

New Delhi, May 30 (UNI): Congress President Mallikarjun Kharge on Thursday expressed confidence that the INDI Alliance will get electoral majority on June 4 and said the leaders of the coalition parties will then sit together and unanimously choose the Prime Minister.

Addressing a press conference at the AICC headquarters here, Kharge while replying to questions said, "We are confident that on June 4, the people will give an alternate mandate and the INDI alliance will form a nationalist and inclusive government that will work for the welfare of the people".

Replying to a question regarding the agenda of the meeting of INDIA bloc leaders to be held on June 1, the Rajya Sabha MP said that this meeting would solely be on the election results.

On Prime Minister Narendra Modi's record interviews to media, Kharge said that if the BJP was winning why were they running from one media to another giving interviews. This only showed that Modi was losing this election. Meanwhile, Congress general secretary K C Venugopal said that the June 1 meeting would only be for the counting preparations. The party has directed its state units to alert about the 17 C form.



People were fed up with Narendra Modi government due to failures on all fronts, he further added. Yadav said that BJP would get wiped out in Lok Sabha election. People would teach a befitting lesson to PM for his false promises made earlier, he pointed out.Meanwhile, former Bihar Chief Minister Rabri Devi predicted that INDIA bloc would cross 300 mark in Lok Sabha election. The BJP led NDA would face crushing defeat, she asserted.

Three die, thousands rescued as flood wreaks havoc in Manipur

(Standard Post Bureau) Imphal, May 30: Three

persons including a woman have died and thousands were evacuated to safe places since Cyclone Remal hit Manipur Monday.

All the major rivers including Nambul, Imphal, Iril, Kongba, and Nambol were flowing above flood levels. Breaches at various parts of the river banks have led to inundation of the Kangla fort, hospitals, the iconic women's markets, and most roads were not safe for travel. Army, Assam Rifles, Manipur Police, and officials worked hard to rescue people stranded in their homes. Local organizations have managed to rescue thousands of people using machinery, makeshift boats while

Assam Rifles personnel have also rescued more than 1000 people and distributed essential commodities.

Thousands of people were living in various relief centres opened by local organizations. Officials said so far three persons including a woman have died in separate incidents and power supplies were cut off in most parts of the state as transformers, power stations were flooded.Manipur government has also opened helplines and the most affected areas were the low-lying valley districts of Imphal East, Imphal West, Thoubal, Bishenpur, and Kakching districts. Heavy rainfall has also affected the hill districts and landslides were reported in the

Ukhrul, Tamenglong, Kangpokpi, Senapati districts.

On Wednesday night a team of the National Disaster Response Force (NDRF) arrived in Imphal by a special Air Force flight.Manipur Governor Anusuiya Uikey and Chief Minister N Biren Singh have appealed to remain calm and help the authorities in helping the affected people. Chief Minister N Biren said Rs 30 crore available in the disaster fund was used to help the affected people.

As both the national highways were cut off efforts were on to restore traffic by opening the Irang bridge. On Tuesday, the Irang Bailey bridge on NH 37, which connects Imphal to Jirbam, had collapsed in Taobam village in Noney district.

Modi, Shah abandoned Tandon after learning he was losing: Tewari

Chandigarh, May 30 (UNI): The INDIA bloc candidate Manish Tewari on Thursday claimed that after coming to know that the BJP candidate Sanjay Tandon was "badly losing" from Chandigarh, both the Prime Minister Narendra Modi and the union Home Minister Amit Shah cancelled their campaign meetings in Chandigarh.

Tewari claimed that for the last few elections, either Modi or Shah compulsorily campaign in Chandigarh for their party candidate.

However, he said, he learnt that both senior BJP leaders cancelled their Chandigarh tour at the last minute, as they did not want to be seen as campaigning for someone who was "losing badly". Tewari also termed as "untrue" BJP leader Piyush Goyal's allegation that lie did not vote in the 2019 Lok Sabha polls."I very much voted in 2019 and I will very much in 2024 also", he asserted.

Four dead in Meghalaya landslide

Shillong, May 30 (UNI): Four persons, including a minor, died after a massive landslide at Nongpriang village under the Shella Community and Rural Development Block in East Khasi Hills district in Meghalaya in the wee hours of Thursday, an official said.

"While the body of one of the victims identified as Phisar Nongrum (75) was retrieved from the debris, Kynmaw Syngai (70) Benti Riahtam (60) and a minor boy, Lumlang Riahtam (16) were trapped under debris," Executive Director, State Disaster Management Authority, Matsiewdor War Nongbri said.

Lumlang Riahtam, K. Syngai and Benti Riahtam belonged to the same familyShe said the search and rescue operations are on.

Meanwhile, Chief Minister Conrad Sangma has directed the district administration to immediately release the ex-gratia to the next of kin. "Sad to hear the news of four of our citizens who are feared dead in a massive landslide at Nongpriang, Shella block. Body of one victim has been found, search operation is ongoing Directed the administration to immediately release the exgratia to the next of kin," Sangma posted on X.

On the other hand, an official report said that due to heavy downpour of water from the hilltop onto the National Highway-6, Lumshnong, East Jaintia Hills district has made the highway "extremely vulnerable and its integrity is doubtful", as a result of which, under the provision of Section 34 (b) and (m) of the Disaster Management Act, 2005, restriction on vehicular movement through this particular stretch has been ordered."All types of vehicular movement through that particular stretch are hereby being prohibited till restorative works are completed.



Braving rarefied air and cold, Himachal tribals gung ho over casting their votes on June 1

) Braving rarefied air and cold temperatures, when plains in northern India are reeling under a debilitating heatwave, voters in high-altitude Himalayan hamlets of Himachal Pradesh are gung ho about exercising their franchise on June 1.

A testament to the dedication to keep democracy alive, the world's highest polling station Tashigang, located at a height of 15,256 feet above sea level, in the Spiti Valley, which is part of the Mandi parliamentary constituency, has 52 registered voters, comprising 30 men and 22 women.

"We are excited to cast our vote for a better future and a better life for generations to come," remarked Tashigang resident Tenzin Lundup.

"Like the last elections (2022 Assembly polls), the polling station in Tashigang would again record 100 per cent polling," added first-time voter, Kalzang Rinchen, a postgraduate preparing for exams for a government job. The Lahaul-Spiti District has the lowest number of electorate -- 25,273 -- in the state, while Kinnaur has 59,943 voters.

The climatic conditions in these districts are harsh as much of the land falls under a cold desert.

The Election Commission of India (ECI) has set up 92 polling stations in Lahaul-Spiti, while in Kinnaur there will be 128 polling stations.

"Polling is a difficult exercise in Lahaul-Spiti, Kinnaur and Chamba as one-third of the polling booths are located at altitudes above 13,000 feet.

He said a majority of polling stations in Lahaul-Spiti and Kinnaur are connected by road.

Electronic Voting Machines (EVMs) and Voter Verifiable Paper Audit Trail (VVPAT) machines for Kaza, some 320 kms from state capital Shimla, were dropped by a helicopter of the Indian Air Force (IAF)

The Spiti Valley has 29 polling stations. Thirteen gram panchayats fall in the Spiti Valley, mainly populated by tribals, who are largely Buddhist farmers.

The gram panchayats are Losar, Kibber, Kaza, Langcha, Demul, Lalung, Dhankar, Tabo, Gue, Hal, Khurik, Kungri and Saganam.

Another remote place in the state is the landlocked Pangi Valley in Chamba District. The Saach Pass is the gateway to the picturesque Pangi Valley.

Located at an altitude of 14,500 feet in Chamba District, it's still closed for motorists after the winter

Resident Commissioner Ritika Jindal, the first woman officer to opt for the Pangi posting, told IANS the material for 39 polling stations has reached Killar, the subdivisional headquarters of Pangi, located in the Pir-Panjal range of the Himalayas, via an IAF

helicopter. The Saach Pass, the shortest road link between Chamba town, some 450 km from the state capital, and Killar is expected to reopen in the first week of July. The Chask Bhatori and Kulal polling stations are

the remotest in the Pangi Valley, where election officials will have to walk a distance of at least 14 km to conduct the poll. The valley last saw snowfall on May 2.Lahaul-Spiti, along with other remote areas of Kinnaur District and Pangi and Bharmour subdivisions of Chamba District, are part of the sprawling Mandi constituency that covers almost two-thirds of the state.In Mandi, Congress legislator Vikramaditya Singh, the scion of the erstwhile royal family, challenges actress Kangana Ranaut of the BJP.

A majority of the booths are scattered over rugged, cold and inhospitable terrain and poll officials have to trek hours to reach there.

Locals are largely Buddhist farmers who grow

barley, potatoes, wheat and black peas.

Before 2019, the highest polling station was Hikkim (14,400 feet) located close to Tashigang. But in 2019, Tashigang was made a polling station.

The state Election Commission has also decided to set up one of the state's remotest polling stations at Bara Bhangal in Kangra District at an altitude of over 2,800 metres not accessible by road. It falls in the Baijnath Assembly constituency that is part of the Kangra parliamentary seat. Situated between the mighty Dhauladhar and Pir Panjal ranges of the Himalayas, Bara Bhangal is considered to be the remotest village with 469 electorates.

Owing to the difficult geographical conditions of the area, an auxiliary polling station will also be set up in Bara Bhangal where the remaining 159 voters will cast their votes. The election official said since most trekking routes leading to Bara Bhangal are blocked by winter snow, helicopter is the only mode of transportation to reach there. However, Bara Bhangal is accessible on foot through the Thamsar Pass, located at an altitude of 4,700 metres. The state ruling Congress has fielded its veteran and four-time Rajya Sabha MP Anand Sharma in his new battleground Kangra, the largest Lok Sabha constituency in terms of voters, against Rajiv Bhardwaj of the BJP, which ignored the sitting MP, Kishan Kapoor.

Successful Surgical Intervention by Dr. Ashish Gupta on a 55-Year-Old Patient

(Standard Post Bureau)

R e n o w n e d neurosurgeon Dr. Ashish Gupta, Senior Director of Neuro Surgery & Spine Surgery, and his medical team at Max Super Speciality Hospital, Patparganj, Delhi, successfully performed a complex minimal invasive spine surgery on Mr. Raben, a 55-year-old male patient from Guwahati. Mr. Raben was admitted with severe neck pain and radicular pain extending into his left upper limb and weakness of hand significantly affecting his quality of life.

Upon admission, Mr. Raben underwent a comprehensive MRI scan of his cervical spine, which revealed several critical issues at the C6-C7 level-Posterior Intervertebral Disc (PIVD), where the disc situated between the sixth and seventh cervical



vertebrae had displaced backward. In Mr. Raben's case, the stenosis at the C6-C7 level was causing compression of the nerve roots exiting at C6 and C7.

Additionally,

exhibited considerable weakness in his right upper limb, indicating that the nerve compression was also affecting his motor functions. This combination of severe pain, nerve compression, and weakness necessitated immediate tissue), and spinal fusion

surgical intervention to prevent further deterioration of his condition and to alleviate his symptoms.



Iran rules out sabotage explosion behind Raisi's helicopter crash

Tehran, May 30 (UNI) Iran on Wednesday ruled out the possibility of a sabotage explosion leading to the helicopter crash that resulted in the deaths of Iranian President Ebrahim Raisi and his entourage, local media reported.

The General Staff of Iran's Armed Forces released the second report on the causes of the helicopter crash on Wednesday, the official news agency IRNA reported. The report said given the results of the tests on the helicopter's wreckage and remaining parts and the way the remains had been scattered at the scene of the incident, as well as their distance from the fuselage, the possibility of an explosion caused by an act of sabotage during the flight or moments before the chopper's crash into the mountain was dismissed.

No sign of electronic warfare was detected on the crashed helicopter, it said, adding that the weather conditions on the way back to Tabriz, the capital of East Azerbaijan province, would need further investigations.

According to the report, the total weight of the passengers and equipment onboard was proportionate to the helicopter's maximum load

limit at the time of takeoff and during the flight.

In addition, during the

flight and until 69 seconds before the incident's occurrence, contact had been maintained with the crashed helicopter's flight crew on the specified frequencies, dismissed the possibility of any disruption in the communication system or frequency interference.

US concerned about Ukraine's strikes on Russia's early warning systems

Washington, May 30 (UNI): The United States is concerned about Ukraine's attempts to strike Russia's missile early

warning systems due to the risk of destabilising the situation, a US BINAYAK TEX PROCESSORS LIMITED official told the Washington Post

on condition of anonymity.

"The United States is concerned about Ukraine's recent strikes against Russian ballistic missile early-warning sites," the official said.

The US told Kiev about its concerns about two attempted attacks last week against radar stations providing conventional air defence as well as warning of Western nuclear launches.

"These sites have not been involved in supporting Russia's war against Ukraine. But they are sensitive locations because Russia could perceive that its strategic deterrent capabilities are being targeted, which could undermine Russia's ability to maintain nuclear deterrence against the United States," the US official said.

The newspaper quoted a Ukrainian official as saying

Ukraine's Military Intelligence Directorate (GUR) was responsible for the strikes.

US media earlier reported that the Biden administration is considering lifting restrictions on Ukraine to strike targets on Russian territory with USsupplied weapons, despite earlier statements that it has not given such authorisation.

Russia has been conducting a special military operation in Ukraine since February 24 2022. President Vladimir Putin has said the operation aims to "protect people subjected to genocide by the Kiev regime for eight years." According to the president, the ultimate goal of the operation is to liberate Donbas and create conditions that guarantee Russia's security.

Russia earlier sent a note to NATO because of arms supplies to Ukraine. Russian Foreign Minister Sergey Lavrov has said any cargo that contains weapons for Ukraine will become a legitimate target for Russia.

EU leaders to strip Hungary of top jobs in commission over resisting aid to Kiev


Brussels, May 30 (UNI): A number of EU leaders are planning to "punish" Hungary for its opposition to supporting Ukraine by barring its representatives from senior posts in the European Commission following elections in June, Politico reported on Thursday, citing three diplomats familiar with the discussions. In March, the Council of the EU raised the ceiling of the European Peace Facility funding for Ukraine by establishing the Ukraine Assistance Fund, providing an extra 5 billion euros (\$5.4 billion) in military aid to Kiev, including lethal and non-lethal military equipment and training. On Monday, Belgian Foreign Minister Hadja Lahbib said that Hungary continued to block the assistance. Hungarian Prime Minister Viktor Orban's EU counterparts intend to provide his country with a weak portfolio for his stance on aid to Kiev when the new EU Commission is elected, the diplomats said. Bangkok, May 30 (UNI) : Indian boxers Nishant Dev and Ankushita Boro have advanced to the quarterfinals of the World Olympic Boxing Qualification Tournament 2024, edging closer to securing spots at the Paris

2024 Olympics. In the men's 71 kg Nishant division, triumphed over Thailand's Peerapat Yeasungnoen with a unanimous 5-0 decision, placing him just one win away from clinching an Olympic quota. In the women's 60 kg category, Ankushita, a former junior world champion, overcame Kazakhstan's Rimma Volossenko by a 4-1 split decision in her round of 16 bout. National champion Arundhati Choudhary also showcased her prowess, advancing to the prequarterfinals of the women's 66 kg weight category with a decisive 5-0 victory against Puerto Rico's Stephanie Pieneiro.

Indian boxers register convincing wins to advance

Bangkok, May 30 (UNI) India's Sachin Siwach (57kg), Sanjeet Kumar (92kg), Amit Panghal (51kg) and Jaismine (women's 57kg) took another step towards Paris Olympic qualification as they registered convincing victories over their respective opponents to advance to the next round of the Boxing World Qualifiers here in Thailand on Thursday.

Siwach started the proceedings for India with a clinical 5-0 win over Olympian Batuhan Ciftci of Turkey in the prequarterfinal round and Sanjeet then saw off the challenge from Luis Sanchez of Venezuela with an identical margin in the Round of 32.As per the rules, in the men's 57kg Category only three boxers will make cut for the Paris Olympic, Siwach therefore needs to win two more bouts to make the cut while Sanjeet, who got a bye in the Round of 64, will have a similar target as all four semi-finalists will qualify in his weight category.Up against an experienced boxer, Siwach came out all guns blazing in Round 1 and that strategy worked wonders for the Indian as he took control of the bout very quickly. He earned a unanimous verdict even in Round 2 and though Ciftci attempted a comeback in the third and final round, the Indian was too comfortable in the end.

The 92kg bout between Sanjeet and Sanchez followed a similar trajectory as the 2021 Asian Championship gold medallist did not allow his Venezuelan opponent to get a look in, in Round 1.

Sanchez did show some spark in Round 2 and 3 but the experienced Sanjeet kept him at bay and landed his punches on counter attacks to win easily.

Later in the day, Jaismine did not give Azerbaijan's Mahsati Hamzayeva any chance of even putting up a fight as she clinched the women's 57kg category Round of 32 bout with a 5:0 verdict.
