The Company's Intimation Letter dated 23rd June, 2020 given to you and referred to above, stands revised accordingly.

Further, in terms of provisions of the Company's "Code of Conduct to regulate, monitor and report trading by its Designated Persons and others" framed under SEBI (Prohibition of Insider Trading) Regulations, 2015, as amended, the Trading Window for dealing in the Securities of the Company by its Designated Persons, which was closed from 1st April, 2020, will now end 48 hours after the Financial Statements for the Financial Year ended on 31st March, 2020 are submitted to the Stock Exchanges.
