Forty First (41st) Annual General Meeting of the Members of Olympic Oil Industries Limited held on Saturday, September 25, 2021 at 03.00 p.m. by means of Video Conferencing (VC)/ Other Audio Visual Means (OAVM)

Dear Sir,

I, Jinesh Dedhia, Proprietor of M/s. Jinesh Dedhia & Associates, Company Secretaries, Mumbai had been appointed as the Scrutinizer by the Board of Directors of **Olympic Oil Industries Limited** ("the Company"), for the purpose of scrutinizing the remote e-voting and e-voting during the Annual General Meeting, pursuant to the provisions of Section 108 of the Companies Act, 2013 ("the Act"), Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended thereto and Circular no. 20/2020 dated May 5, 2020 read with Circular No. 14/2020 dated April 8, 2020, General Circular No.17/2020 dated April 13, 2020 and General Circular No. 02/2021 dated January 13, 2021 (collectively referred to as "MCA Circulars") and Regulation 44 of SEBI (Listing Obligations And Disclosure Requirements) Regulations, 2015 read with Securities and Exchange Board of India ("SEBI") vide its circular no. SEBi/HO/CFD/CMDI/CIR/P/2020/79 dated May 12, 2020 and circular no. SEBI/HO/CFD/CMD2/ CIR/P/2021/11 dated January 15, 2021 (collectively referred to as "SEBI Circulars") and Secretarial Standard - 2 on General Meetings as issued by the Institute of the Company Secretaries of India, on the business contained in the Notice of the 41th Annual General Meeting ("AGM") of the Company held on Saturday, September 25, 2020 at 03.00 p.m. through VC / OAVM.

The notice of AGM dated August 14, 2021, were sent to the shareholders, in respect of the resolutions passed at the AGM of the Company through electronic mode to those Members whose email addresses are registered with the Company/ Depositories, in compliance with the MCA Circulars and Securities and Exchange Board of India Circular. The Company had availed the e-voting facility offered by National Securities Depository Limited ("NSDL") for conducting remote e-voting by the Shareholders of the Company.

The Management of the Company is responsible to ensure compliance with the requirements of the Act and rules relating to remote e-voting and e-voting during the AGM on the resolutions

contained in the notice of the AGM. My responsibility as Scrutinizer for the remote e-voting is restricted to making a Scrutinizer's Report of the votes cast in favour or against the resolutions. Based on the reports generated from the remote e-voting system provided by National Securities Depository Limited (NSDL / Service Provider), the authorized agency to provide remote e-voting facility and voting at the AGM.

I hereby submit my report as under:

- 1. The Company had appointed NSDL as the Service Provider, for the purpose of extending the facility of remote e-voting and e-voting at the AGM to the members of the Company.
- 2. Link Intime India Private Limited are the Registrar & Share Transfer Agents (RTA) of the Company.
- 3. The Cut-off date for the purpose of identifying Members who were entitled to vote on resolutions was considered as September 17, 2021.
- 4. As prescribed under the circular dated May 5, 2020 issued by MCA, the Company has released an advertisement prior to sending notices to the Shareholders in Marathi in 'Mumbai Lakshdeep' dated August 24, 2021 and in English in 'Business Standard' dated August 23, 2021.
- 5. The Company has completed dispatch of notices by email to the members by September 03, 2021.
- As prescribed in Rule 20 of Companies (Management and Administration) Rules, 2014, Company also released notice through newspaper Advertisement in Marathi in 'Mumbai Lakshdeep' dated September 06, 2021 and in English in 'Business Standard' dated September 06, 2021.
- In terms of the Rule 20 of Companies (Management and Administration) Rules, 2014 the Remote e-Voting facility was kept open for Three (3) days i.e. from Wednesday, September 22, 2021, 9:00 a.m. IST till Friday, September 24, 2021, 5:00 p.m. IST.
- 8. At the end of the voting period on September 24, 2021 at 5.00 p.m., the voting portal of the Service Provider was blocked forthwith.
