In furtherance of our letter of even date communicating outcome of Board Meeting, it is hereby informed that the Board of Directors, in its meeting held on even date approved/considered/took note of the following matters:

- Approved the appointment of Key Management Personnel ('KMP')/ Senior Management Personnel ('SMP') and change in role and designation of KMP/SMP, wherever applicable.
- Took note of resignation tendered by HR-Head, existing SMP. Resignation letter is enclosed herewith.

The detailed disclosure as required under Regulation 30 of the SEBI Listing Regulations read with SEBI Circular No. SEBI/HO/CFD/ CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023 is enclosed as Annexure-A.

- Based on recommendation of Nomination and Remuneration Committee, approved grant of 45,750 stock options to the eligible employees at a price of Rs. 550/- (Rupees Five Hundred and Fifty) per option under the Employees Stock Option Plan -2016 (8th Tranche). The price, vesting and exercise of these grants shall be in accordance of ESOP-2016 Plan of the Company, formulated in compliance of the SEBI (Share-Based Employee Benefits and Sweat Equity) Regulations, 2021.

Please also note that, a Separate meeting of Independent Directors was also held on the even date in which the Independent Directors reviewed the performance of Non-independent Director, Board as a whole including its Committees, performance of the Chairperson of the Company taking into account views of Executive and Non-Executive Directors.

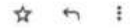
