Redevelopment of Mumbai BDD Chawls Kicked Off

First phase in Worli to be developed by Tata Projects and Capacite Infraprojects

Mumbai: The Maharashtra government has kick-started the much-awaited redevelopment of chawls which are spread over 92 acres in central Mumbai's prime localities of Worli, Lower Parel and Dadar.

The revamp of the over-a-century-old Bombay Development Department (BDD) chawls will be one of the largest cluster redevelopment projects in Asia to be led by a state government.

On Sunday, Maharashtra chief minister Uddhav Thackeray and NCP leader Sharad Pawar jointly laid the foundation stone of the project.

The first part of the project will start with redevelopment of 121 chawls spread over nearly 60 acres in Worli with around 10,000 residential units. Out of 195 BDD chawls, Worli has the maximum number of chawls.

The Maharashtra Housing and Area Development Authority (MHADA) has been appointed as the nodal agency for the entire project, while a consortium of Tata Projects and Capacite Infraprojects will undertake the project's Worli phase. The Tata Group entity holds 65% in this consortium and Capacite holds the rest. The total cost of redevelopment at all three locations — Worli, Lower Parel and Dadar — is estimated to be ₹17,000 crore.

As per the plan for an entire township at Worli, a total of 33 redevelopment buildings with 40 floors each will be constructed. Each of these buildings will have ground and six floors with podium parking. The project will also have separate buildings to include hospitals, hostels, schools and gymkhana.

Maharashtra housing minister Jitendra Awhad has also promised to provide houses to the families of police personnel living in BDD chawls in Worli. As part of the redevelopment project, residents of these chawls will get 500-sq-ft houses for their existing 160-sq-ft tenement. At Worli, MHADA has completed a survey of 14 buildings to assess

the eligibility of tenants. A similar survey is yet to start at Dadar, while assessment at 10 buildings out of a total of 32 at Lower Parel's Dellsie Road locality has been completed.

Initially used as jails in the British era, these buildings were converted into housing units for the economically weaker sections of the society in the 1920s. To tackle the housing shortage in the backdrop of rising industrial activities in Mumbai, the BDD was set up by Sir George Lloyd, the then governor of Bombay province.

ईशान्येतील सीमासंघर्ष

ईशान्येकडील आसाम आणि मिझोरम या राज्यांमधील सीमावाद दीड शतकांहून अधिक जुना आहे. मात्र आजवर त्याची परिणती हिंसाचारात फारशी कधी झाली नव्हती. गेल्या आठवड्यात मात्र या राज्यांच्या सीमेवर अभूतपूर्व हिंसाचार उसळून आसामच्या सहा पोलिसांचा मृत्यू झाला. त्या घडामोडीमुळे या सीमासंघर्षाला धार आल्याचे दिसते.

राज्याराज्यांतून आसाम-मिझोरम

'१९३३च्या सीमा आरेखानुसार, लुशाई जमातीचे वास्तव्य असलेला कचर झिओन, तलांगनुआम, लाला बाजार, बंगा बाजार हा भाग मिझोरममधून वेगळला असून आमच्या सहभागीनाच ही सीमा लादली आहे,' अशी स्पष्ट भूमिका यात मांडली आहे. दरम्यान अनेकदा बैठका, चर्चा होऊनही या वादावर तोडगा निघालेला नाही. संपूर्ण ईशान्य भारतातच असलेला बांगलादेशाच्या स्थलांतराचा एक वेगळा कंगोराही या मुद्द्याला आहे.

या पाश्चिमीवर, गेल्या वर्षभरात आसाम-मिझोरम राज्यांमधील सीमाभागात जमीनवादातून धिके जाळणे, आसामच्या अधिकाऱ्यांकडून धाकदपटशाच्या तक्रारी मिझोरमकडून करण्यात येत आहे. गतवर्षी जूनमध्ये मिझोरममधील मांमिंत जिल्ह्यात आसामच्या अधिकाऱ्यांनी बळाने प्रवेश केला, कोलासिब जिल्ह्यात समाजकटकांनी शेतातील झोपड्या जाळल्या, मिझोरममधील वैरंगटे आणि आसाममधील लैलापूरदरम्यानच्या आसाम पोलिसांनी बळाने चौकी ओलांडल्याचे आरोप झाले. बुआरचेप गावात दोन्ही राज्यांनी बांधकामे सुरू केल्याने वाद उसळला. आसाम पोलिसांनी मिझोरममधील सैहापुरी येथे घुसखोरी करत आंतरराज्य महामार्ग बंद करण्याची धमकी दिली. त्यानंतर लैलापूर येथे महामार्ग रोखण्यातही आला. नोव्हेंबरमध्ये मिझोरममधील अपर फेनुआम येथे शाळेत बॉम्बस्फोट झाला.

मिझोरममधील वैरंगटे आणि आसाममधील लैलापूरमधील रहिवासी यांच्यात तसेच आसाममधील करीमगंज आणि मिझोरममधील मिमिडत येथील ग्रामस्थांमध्येही संघर्ष झडला आहे. आपण हद्दीच्या रक्षणासाठी हे करत असल्याचे आसामचे म्हणणे आहे.

गेल्या आठवड्यात काय घडले? गेल्या आठवड्यात आसामच्या २०० पोलिसांच्या पथकाने पोलिस महानिरीक्षकांच्या नेतृत्वाखाली वैरंगटे येथे जाताना, सीआरपीएफ, तसेच मिझोरम पोलिसांचे ठाणे घुडकावून घुसखोरी केल्याचा आरोप मिझोरमने केला, तर मिझोरमने 'जेसे थे' स्थितीचा भंग करून आसाममधील रंगटी बस्ती येथे रस्ता, तसेच सशस्त्र ठाण्याचे सुरू केलेले काम थांबवावे, अशी विनंती करण्यासाठी हे पथक तिथे गेल्याचा दावा आसामने केला. यावेळी झालेल्या हिंसाचारात आसामचे सहा पोलिस मृत्युमुखी पडले. केंद्रीय गृहमंत्री अमित शहा यांनी ईशान्येतील मुख्यमंत्र्यांशी चर्चा केल्यानंतर दोनच दिवसांनी ही घटना घडली. चकमकीनंतर दोन्ही मुख्यमंत्र्यांच्या टिटरयुद्धामुळे या वादास राजकीय रंग चढला. आसामने मिझोरममध्ये प्रवासासाठी मार्गदर्शक सूचना प्रसिद्ध केल्या, मिझोरमच्या सहा अधिकाऱ्यांना समनस बजावले. मिझोरमने आसामचे मुख्यमंत्री, वरिष्ठ पोलिस अधिकाऱ्यांवर एफआयआर दाखल केला. आसाममध्ये भाजपचे, तर मिझोरममध्येही भाजपप्रणित एनडीएचा घटक असलेल्या मिझो नॅशनल फ्रंटचे सरकार असल्याने तोडग्याची अपेक्षा असताना हा वाद हिंसाचारापर्यंत चिधळला आहे.

मिझोरममधील राजकीय पक्ष व संस्थांनी २०१८मध्ये याबाबत पंतप्रधान नरेंद्र मोदी यांना पत्र लिहिले होते.
