Centre Notifies GST Amnesty Scheme

New Delhi: Goods and Services Tax (GST) taxpayers who could not file an appeal against orders of tax authorities till March 31, 2023, can now do so until January 31, 2024.

The Centre on Thursday notified the amnesty scheme allowing more time for taxpayers who had earlier missed the deadline after fulfilling certain criteria to implement the decision taken at the GST council meeting. The scheme will cover taxpayers who could not file it for technical or admin-

istrative reasons and will also include those whose appeals were previously rejected solely due to the failure to meet the specified time limit as defined in section 107 of Central GST Act. The central Board of Indirect Taxes and Customs (CBIC), in a notification on Thu, said taxpayers will be allowed to appeal till the extended date. However, they have to make partial payment of the penalty or interest for the tax demand against which they are filing an appeal. They also have to pay a higher predeposit of 12.5% of the disputed tax amount or ₹25crore, out of which 20% payment has to be done

via electronic cash ledger. This is 2.5% higher than the current pre-deposit of 10% required to file an appeal.

The move was approved by the GST Council in its last meeting, keeping in mind many appeals pending in various high courts.

As Air Turns Toxic, NCR Cos Take Steps to Protect Staff

THE MEASURES Allow more flexibility on work-from-home, install air purifiers in offices

New Delhi | Bengaluru: With the air quality index (AQI) breaching hazardous levels in and around the National Capital Region, corporate India is stepping up measures to shield employees from the perils of toxic air.

The AQI crossed 700 (a value above 150 is considered unhealthy) in many parts of the NCR on Thursday, forcing the shutting down of primary schools. Over a dozen companies including Deloitte, KPMG, Panasonic, BigBasket, BluSmart, Zepto and CIEL HR Services that ET spoke with said they are taking initiatives include offering work-from-home options to employees, providing masks at offices and to frontline staff, installing air purifiers and indoor plants as well having a doctor on call.

Professional services firm Deloitte has issued an advisory on precautions that employees should take as the AQI dips to hazardous levels."Considering we operate on a hybrid model, our people are well-equipped to WFH when advisories are issued by public authorities against stepping outside for non-essential work," said Deepti Sagar, chief people and experience officer, Deloitte India.

In case employees at Deloitte still face any adverse symptoms, they are encouraged to take a well-being day off. "This is a leave facility over and above the annual leave entitlement," said



Sagar. In addition, Deloitte is also working with the Haryana government on a crop residue management project to reduce instances of stubble burning, which is often blamed as one of the factors contributing to increased air

pollution during winter. BluSmart, which offers ride sharing with electric vehicles, is providing subsidised rates on its platform for its employees to encourage them to use the eco-friendly mode of transportation. "In addition to this, we are seeing a rising trend of multiple organisations opting

for Blu for Business - which is our B2B offering for corporate clients to manage their transportation requirements," said cofounder and chief operating officer Anirudh Arun.

Panasonic is allowing employees to work from any location in case they feel unwell and ask for it. "While the sales team is excited and geared up for the ongoing festive season, they have been advised to take required precautions like wearing masks, consumption of adequate liquids, taking steam, etc.," said chief HR officer Adarsh Mishra.

Fairplay Regulator Starts Study on Cement Sector

New Delhi: The Competition Commission of India (CCI) is launching a pan-India market study on the cement sector, players in which have often been accused of forming cartels to influence pricing, to develop a comprehensive understanding of the sector and the state of competition in it, the anti-trust regulator said on Friday.

However, the study will be independent of any case proceedings before the CCI pertaining to the anti-competitive behaviour of cement firms, the CCI said in a statement. "Given the criticality of cement for many vital sectors, a wellfunctioning and competitive cement market is of utmost importance. In view of the same and given the structural features of cement market that make it susceptible to collusion, the market study will be a fact-finding exercise to develop comprehensive un- of cement firms derstanding of the functioning of cement market across regions in with a range of other industries. the CCI said. First, it will aim to "examine the evolving market structure in the cement sector across regions including inter alia market concentration, entry/exit and consolidation". Second, it will assess the market trends, including the movements in cement price, cost, production, capacity, capacity utilisation and profitability. Third, it will gauge cement pricing in trade and non-trade segments and have an in-

depth analysis of the drivers of cement prices. Fourth, it will reach out to stakeholders for a holistic understanding of the sector and identify impediments to competition, if any. And fifth, it will ascertain enforcement and advocacy priorities for the regulator in the cement sector.

Cement players have often been in regulatory crosshairs. Last year, the CCI found that more than a dozen cement manufacturers had colluded to raise prices and restrict supplies for years. In 2016, the regulator had asked 11 cement companies and their lobby group Cement Manufacturers Association (CMA) to pay a fine of ₹6,714 crore for alleged cartelisation. In 2012, it had ordered 10 companies to pay ₹6.317 crore after the Builders Association of India accused them of fixing prices. These fines subsequ-


