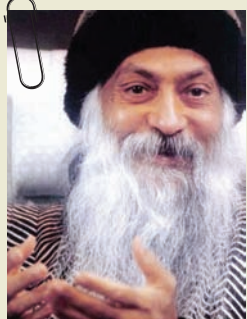

थे, दो का ही आर्डर देना. दोनों गिलास तुम पी लेना—एक तुम्हारे लिए, एक भरे लिए. इससे मेरी आत्मा को बड़ी शांति रहेगी. मुल्ला ने कहा अरे, यह भी कोई बात. जरूर करूंगा. इससे अच्छा और क्या. मुल्ला तो ऐसा प्रसन्न हो गया कि अच्छा ही हुआ कि मित्र मर रहा है. मित्र तो मर गया, मुल्ला दो गिलास बुलाकर पीने लगा. जब भी कोई पूछता

कि दो गिलास क्यों, अकेले तो तुम हो, वह कहता—एक मित्र के लिए. मित्र तो मर चुका है. सारे गांव में खबर हो गयी कि जहां भी जाये, वह दो गिलास बुलाकर पीए. फिर एक दिन शराबघर में आया एक ही गिलास का आर्डर दिया. तो शराब घर के मालिक ने कहा, नसरूदीन बात क्या है, क्या मित्र को भूल गये. नहीं, उसने कहा यह बात नहीं, डॉक्टर ने कहा है कि नसरूदीन

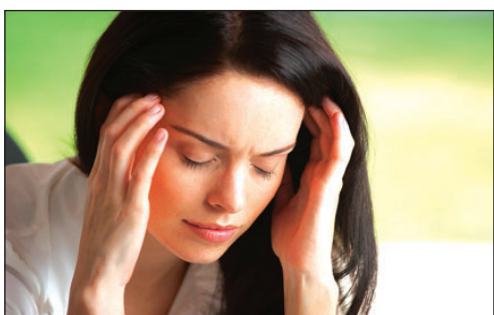
