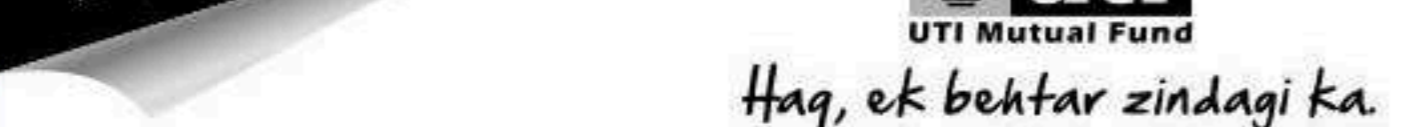

कोटा/नि.सं। एलेन स्टूडेंट्स वेलफेयर सोसायटी (एएसडब्ल्यूए) सामाजिक सरोकार व जनहित के तहत एक नई पहल की जा रही है, जिसमें सघन कोचिंग क्षेत्रों से डोर-टू-डोर लिए जाने वाले कचरे से बिजली बनाने के साथ-साथ जैविक खाद भी बनाई जाएगी।

संस्था के अध्यक्ष मुकेश सारस्वत ने बताया कि कोचिंग सिटी कोटा मेडिकल व इंजीनियरिंग प्रवेश परीक्षाओं की तैयारी करने के लिए डेढ़ लाख से अधिक स्टूडेंट्स कोचिंग संस्थानों में पढ़ रहे हैं। वहीं शहर की आबादी और शहरीकरण भी तेजी से बढ़ रहा है। बढ़ते शहरीकरण, जनसंख्या वृद्धि और सीमित संसाधनों के चलते कोटा कचरे के निस्तारण की समस्या बढ़ती जा रही है। कोचिंग क्षेत्रों में सघन आबादी होने के कारण कचरा अधिक हो रहा है और इन क्षेत्रों में कचरा एकत्रिकरण और परिवहन एक बड़ी चुनौती है।
