3. 2. Select “EVEN” of company for which you wish to cast your vote during the remote e-Voting period.
3. Now you are ready for e-Voting as the Voting page opens.
4. Cast your vote by selecting appropriate options i.e. assent or dissent, verify/modify the number of shares for which you wish to cast your vote and click on “Submit” and also “Confirm” when prompted.
5. Upon confirmation, the message “Vote cast successfully” will be displayed.
6. You can also take the printout of the votes cast by you by clicking on the print option on the confirmation page.
7. Once you confirm your vote on the resolution, you will not be allowed to modify your vote.

General Guidelines for shareholders

1. EXPLANATORY STATEMENT PURSUANT TO SECTIONS 102 AND 110 OF THE COMPANIES ACT, 2013

The Members of the Company at its 32nd Annual General Meeting held on September 30, 2023 had appointed M/s TEJAS K. SONI, Chartered Accountants (FRN: 135093W) as the Statutory Auditors of the Company to hold office for a period of Four (4) consecutive financial years from 2023-24 to 2026-27, However, TEJAS K. SONI, Chartered Accountants vide their letter dated November 14, 2024 have resigned from the position of Statutory Auditor of the Company, resulting into a casual vacancy in the office of Statutory Auditor of the Company as envisaged by Section 139(8) of the Companies Act, 2013.

As per the provisions of Section 139(8)(i) of the Companies Act 2013, any casual vacancy caused in the office of Statutory Auditor shall be filled by the Board of Directors within thirty days from the date of resignation of such auditor and shall also be approved by the Company within three months of the recommendation of the Board and he shall hold the office till the conclusion of the next annual general meeting.

Your Board approached to M/S M. A. Shah & Co, Chartered Accountants (FRN 0112630W) to act as Statutory Auditor of the Company and received their affirmation. Therefore, Board of Directors in their meeting held on December 13, 2024, on the recommendation of Audit Committee has recommended the appointment M/S M. A. Shah & Co, Chartered Accountants (FRN 0112630W) as a Statutory Auditor to fill the casual vacancy caused by the resignation of M/s TEJAS K. SONI, Chartered Accountants (FRN: 135093W) and to hold office as the Statutory Auditor of the Company till the ensuing Annual General Meeting of the Company to be held in the year 2025 subject to the approval by the members, at such remuneration plus applicable taxes, and out of pocket expenses, as may be determined and recommended by the Audit Committee in consultation with the Auditors and duly approved by the Board of Directors of the Company.

The Company has received consent letter and eligibility certificate from M/S M. A. Shah & Co, Chartered Accountants (FRN 0112630W) to act as Statutory Auditor of the Company along with a confirmation that, their appointment, if made, would be within the limits prescribed under the Companies Act, 2013.
