Sub: Disclosure under Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations")

This is to inform you that in accordance with the applicable provisions of Maharashtra Stamp Act 1958, the Hon'ble Collector of Stamps, Enforcement-1, Mumbai, Government of Maharashtra has issued a notice of demand dated 22nd March 2024 ('Notice') imposing a penalty of ₹ 99.99 lakh on Aditya Birla Renewables Limited, a wholly owned subsidiary of the Company on account of non-payment of stamp duty upon adjudication of the Hon'ble National Company Law Tribunal (NCLT) order dated 23rd June 2023 in respect of sanctioning the scheme of arrangement between Aditya Birla Solar Limited and Aditya Birla Renewables Limited.

The requisite details as required Regulation 30 and sub-para 20 of Para A of Part A of Schedule III Listing Regulations and SEBI circular no. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023, as enclosed in Annexure A.
