Sub.: Intimation of Closure of trading window for specified persons.

Pursuant to the SEBI (Prohibition of Insider Trading) Regulations, 2015, as amended and the clarification issued by BSE Limited dated 02nd April, 2019, the Trading Window for dealing in the shares of the Company shall remain closed from 1st July, 2023 till 48 hours after the declaration of Financial Results for the quarter ended 30th June, 2023 for Designated Persons, Designated Employees and their Immediate Relatives.

Designated Persons, Designated Employees and their immediate relatives shall mean as under:

“Designated Person” with regard to the Company means any of the following persons:

- (b) Promoters of the Company
- (c) Any other key person, who in the opinion of Compliance Officer be covered in the “Designated Person”;

“Designated Employee” means a person occupying any of the following position in the Company:

- (a) All Directors and Chief Vigilance Officer
- (b) Key Managerial Personnel
- (c) All Executive Directors
- (d) All General Managers
- (e) All Heads of Finance of Units/Divisions/Regions
- (f) All Employees working in Books, Budget, Financial Service and Direct Taxation Sections of Corporate Finance
- (g) All employees working in Company Secretariat & Legal Deptt.
- (h) All employees working in Secretariat of MD/Functional Directors
- (i) Any support staff such as IT staff who have access to Unpublished Price Sensitive Information (UPSI).
- (j) Any other key person, who in the opinion of Compliance Officer be covered in the “designated employee”;

“Immediate Relative” shall mean a spouse of a person and includes parent, sibling and child of such person or of the spouse, any of whom is either dependent financially on such person or consults such person in taking decisions relating to trading in securities.
