Sub: Disclosure under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015- investment in foreign associate.

In terms of SEBI Listing Regulations, we hereby inform that based on the recommendation of the Audit Committee, the Board of Directors of Company at its meeting held on 21st July, 2022, have decided to invest in the rights issue of M/s Karnalyte Resources Inc. upto an amount not exceeding CAD 3.25 Mn. equivalent to \sim Rs.20 Crs.

Karnalyte Resources Inc. (KRN) is an advanced potash development/ mining company situated in Saskatchewan, Canada and listed on Toronto Stock Exchange. GSFC has made a strategic investment (presently holding 38.73%) in the project in 2013 to meet its potash requirements.

Karnalyte has raised the Rights Issue for 14,058,282 shares (ratio of 3:1 for existing shareholders) at a price of CAD 0.35 per share. The rights issue opened on 28th June'22 and the offering shall expire on 29th July'22.

The proposed rights issue is with an intent to part finance its immediate funding requirements of CAD 4.9 Mn.

With a view to partly fund the immediate funds requirements of Karnalyte Resources, the Board of Directors of Company (upon recommendation of the Audit Committee), at its meeting held on 21st July, 2022, has approved to subscribe the Right Issue of M/s Karnalyte Resouces INC., as above
