- (ii) Shri Sanjay Swarup (DIN: 05159435) has taken over the charge of the post of CMD/CONCOR w.e.f. 01.10.2023.

In compliance with SEBI Circular No.LIS/COMP /14/2018-19 dated 20.06.2018 and as per the confirmation received from Shri Sanjay Swarup, it is confirmed that he has not been debarred from holding the office of Director by virtue of any SEBI order or any other such authority.
