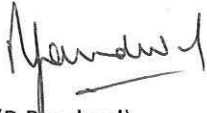

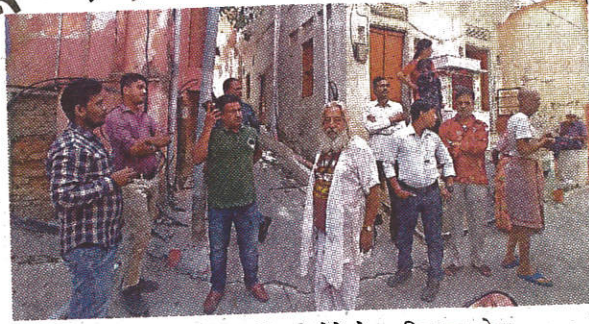

# पार्षद जोशी ने एलएनटी के इंजीनियरों को बुलाया तो हुआ खुलासा स्मार्ट सिटी कंपनी पुरानी लाइन को नई लाइन से जोड़ना भूली, वारियों की घाटी में पानी बंद

स्मार्ट सिटी कंपनी की लेटलतीफी के बाद अब कामों में भी एक के बाद एक लापरवाहियां सामने आती जा रही हैं। बुधवार को जल वितरण से जुड़ा मामला सामने आया। भीतरी शहर के वारियों की घाटी क्षेत्र में पांच दिन से जल वितरण नहीं होने से आक्रोशित लोग सड़क पर उतर आए। उनका कहना था कि गुरुवार को जल वितरण का टर्न था, लेकिन पानी नहीं आया। ऐसा दूसरी हुआ है। लोगों के सड़क पर उतरने की सूचना पर क्षेत्रीय पार्षद कुलदीप जोशी भी मौके पर पहुंच गए। लोगों ने उन्हें बताया



वारियों की घाटी क्षेत्र में जलापूर्ति नहीं होने से एकत्रित हुए लोग।

कि क्षेत्र की दो गलियों के नल पांच दिन से सूखे पड़े हैं। 40 घरों में पानी की एक बूंद नहीं है। इस पर पार्षद ने एलएनटी के इंजीनियरों को मौके

पर बुलाकर दिखाया तो पता चला कि इन गलियों की पुरानी लाइन पेयजल लाइनों को स्मार्ट सिटी कंपनी के कर्मचारियों ने नई लाइन से जोड़ी ही

नहीं है। अब तक पुरानी लाइन से ही जल वितरण किया जा रहा था, जिसमें कचरा फंस गया और गलियों में पानी ही नहीं पहुंचा। इससे पांडेजी की पोल, पुरोहितजी की हवेली आदि क्षेत्र में लगातार दूसरी बार जल वितरण नहीं हुआ। इस पर एलएनटी के इंजीनियरों ने स्मार्ट सिटी के इंजीनियरों के पास भेज दिया। लोगों को तुरंत राहत देने के लिए आसपास के लोगों से राइप मांग कर सरकारी और निजी नलों से पानी पहुंचाया। ऐसे में केवल पीने का पानी ही मिल पाया। इसी प्रकार की समस्याएं गत दिनों घाणोराव की घाटी पर भी आई थी। इन गलियों के कनेक्शन जल्द नई लाइन से जुड़ावों।

उदयपुर में कन्हैयालाल हत्याकांड की गुंज गुरुवार को लोकसभा में सुनाई दी। इस पूरे मामले के हत्यारों को फांसी देने की भी मांग हुई। उदयपुर सांसद अर्जुन लाल मीणा ने लोकसभा में नियम 377 के तहत यह मुद्दा उठाया। उन्होंने इसकी सुनवाई स्पेशल कोर्ट में लेकर दोषियों को फांसी की सजा देने की मांग की। उदयपुर सांसद अर्जुनलाल मीणा ने सभा पटल के सामने बताया कि उदयपुर में सांप्रदायिक दंगे फैलाने की साजिश रची गई थी। 28 जून को

उनकी दुकान में घुसकर हत्या कर दी गई थी। हत्या के बाद सांप्रदायिक तनाव के हालात हो गए। इस पूरे मामले को लेकर जांच एजेंसियां काम कर रही हैं। उन्होंने कहा कि इस हत्या के तार पाकिस्तान के दावत-ए-इस्लामिक संगठन से जुड़े हैं। पाकिस्तान से ऑपरेट हो रहे इस संगठन का असल मकसद भारत में दहशत फैलाना और सांप्रदायिक दंगे करवाना है। इसे लेकर सांसद अर्जुन लाल मीणा ने सरकार से मांग की है कि राजस्थान में लगातार फैल रहे दावत-ए-इस्लामिक संगठन पर अति शीघ्र प्रतिबंध लगाया जाए। सांसद ने कहा कि उदयपुर शहर की शांति, सुरक्षित और निडर गलियों में फिर से कोई दरिदा इस तरह की हरकत नहीं कर सके। इस पर कठोर कार्रवाई होनी चाहिए।
