The MP Nagar police have booked a former employee of a construction company who duped to the tune of Rs 2.37 crore from the owner of the company. The owner of the company Rajesh Sharma operates Trishul Construction Company and had to collect money from his acquaintance. For this, he told the accountant Harsh Verma to provide his bank account number from his mobile to the person providing money. The accountant sent his account number in the message instead of the owner. After this he received about Rs 2.37 crore in his account. Later he left the job and escaped.

On receiving the complaint, the police investigated. After investigation, a case of embezzlement and cheating was registered and investigation was started. TI Sudhir Arjaria told that Govindpura resident Rajesh Sharma is the director of Trishul Construction Company. Harsh Verma used to work with him as he wanted to learn the construction business. While working together, Harsh gained director's trust so he made him an accountant temporarily. Since the company does many types of government and non-government work, transactions of lakhs and crores of rupees keep happening. Money transactions of Rajesh Sharma continue with many private parties as well. In November 2022, he asked a

friend for more than Rs 2 crore for business. After this he asked Harsh to message his account number to his friend. Harsh, instead of messaging the account number of director Rajesh Sharma, messaged his own bank account number and Rajesh Sharma transferred Rs 2.3760 crores in two parts. The next day, Harsh suddenly left the job and escaped and also switched off the mobile phone. When Rajesh Sharma got the bank accounts checked, the rigging came to light. matter to the police. The police have registered a case of embezzlement and cheating against Harsh. During the investigation it was found that Harsh is a resident of Allahabad, the police reached there in search of him but found out that only his brother lives there.
