## Diksha misses first cut in four months, Sharma T-20 in Scandinavian

Helsingborg (Sweden): Diksha Dagar missed her first cut since February this year as she exited early in the Volvo Car Scandinavian Mixed Open. Diksha shot rounds of 75 and 73 over two days and fell well short of the cut line. She was 4-over and the cut fell at 2-

under. She had three birdies in the second round but also gave away four bogeys. She had one birdie and three bogeys on the opening day. This was Olympic-bound Diksha's second missed cut in the season during which she has had three top-10 finishes.

## Alcaraz seeks third Grand Slam title

When Carlos Alcaraz was a kid growing up in Spain - which, considering he's only 21, was not all that long ago - he used to run home from school and flip on the TV to check out the French Open. Long before he was preparing to play in Sunday's final in Paris against Alexander Zverev, Alcaraz watched a lot of matches involving Rafael Nadal, of course, as his countryman was accumulating a record 14 titles at Roland Garros. "I wanted to put my name on that list of the Spanish players who won this tournament. Not only Rafa," said Alcaraz, who then rattled off champions such as Juan Carlos Ferrero (who happens to be his coach), Carlos Moya and Albert Costa, calling them "legends from our sport that won this tournament." He just might join them. Alcaraz has triumphed on the US Open's hard courts in 2022 and Wimbledon's grass courts in 2023, and now, he is one victory away from holding a trophy on the red clay of Court Philippe Chatrier in southwest Paris.

# SWIATEK CLINCHES FOURTH TITLE

The top seed defeated Jasmine Paolini convincingly in straight sets

Iga Swiatek won her third consecutive French Open championship and fourth in five years by defeating Jasmine Paolini 6-2, 6-1 in the final on Saturday. The top-seeded Swiatek trailed 2-1 early in Court Philippe Chatrier before taking the opening set and go up 5-0 in the second. She stretched her winning streak at Roland Garros to 21 matches, and her career record at the place is now 35-2. The 23-year-old from Poland is the first woman with three trophies in a row in Paris since Justine Henin from 2005 to 2007. Swiatek also won the French Open in 2020 and the US Open in 2022 and is now 5-0 in major finals. The 12th-seeded Paolini, a 28-year-old from Italy, was appearing in a Slam final for the first time. She had never been past the second round at one of the four most important tennis tournaments until getting to the fourth round at the Aus-



tralian Open in January. Paolini will play in the French Open women's doubles final on Sunday with partner Sara Errani against 2023 US Open singles champion Coco Gauff and Katerina Siniakova.

After a scare in the second round against Naomi Osaka, when Swiatek needed to save a match point, this represented a fifth straight lopsided win. Swiatek took every set in that span and only ceded a total of 17 games.

## DE GROOT, TOKITO WIN WHEELCHAIR TITLES

Paris: Top-ranked Diede de Groot won a record 22nd Grand Slam wheelchair singles title when she rallied to beat unseeded Zhu Zhenzhen 4-6, 6-2, 6-3 in the French Open women's final on Saturday. In the men's wheelchair final, second-seeded Tokito Oda of Japan successfully defended his title at Roland Garros by winning 7-5, 6-3 against No. 3-seeded Argentine Gustavo Fernandez. It was the 18-year-old Oda's fourth major title. The 27-year-old De Groot's victory saw her overtake her Dutch compatriot Esther Vergeer for the most women's singles titles. "Of course, I'm really proud to now have this record, but at the same time, I know the conditions when Esther played," De Groot said. "She couldn't play singles at Wimbledon. A lot of the Grand Slams weren't even called Grand Slams yet. So, it's really not much of a comparison." Vergeer had a 470-match winning streak.

**Aman nets hat-trick in Conscient 3-0 win**  
Mumbai: Striker Aman Shaikh was in excellent striking form as he scored hat-trick to steer Conscient FC to a fluent 3-0 win against Ummat Milan FC in a Third Division match of the Mumbai Football Association (MFA) League 2023-2024, played at the Bombay YMCA ground, Mumbai Central on Saturday. The dashing forward Aman hit the target in the very fourth minute to give Conscient an early lead. He then scored two quick goals in the second half to complete the fluent win for his team. In another match of the same division, Our Lady of Fatima SC after conceding an early goal gallantly fought back to record an authoritative 6-1 win against V.R. Academy and pocket all the three points. Leading Our Lady of Fatima's charge was striker Anthony Fernandes who struck two goals, while Lionel Fernandes, Aryan Marchande, Damor Saumil and Jason F. contributed one goal apiece to round-off the winning tally. V.R. Academy had taken the lead through Aaraya J snap goal. **More details available online on our website.**

**Scheffler's big finish gives him 3-shot lead**  
Dublin (USA): Masters champion Scottie Scheffler is only making it look easy right now. It didn't feel that way Friday on a firm course in gusty wind, where he finished strong for a 4-under 68 to go from a tie to a three-shot lead in the Memorial. Scheffler hit a 3-iron into the wind that narrowly cleared the bunker and rode the slope to 8 feet for eagle on the par-5 15th, and he closed with two solid par saves and a shot from a fairway bunker to 12 feet for birdie on the last to build some separation. He was at 9-under 135, three shots ahead of Viktor Hovland and Adam Hadwin, chasing another \$4 million prize against a suddenly smaller field. The Memorial is a signature event with a \$20 million purse, but the three tournaments with player hosts - the Arnold Palmer Invitational, Genesis Invitational (Tiger Woods) and Memorial (Jack Nicklaus) - have a 36-hole cut to top 50 and ties. That sent home 22 players, a list that includes Jordan Spieth, U.S. Open champion Wyndham Clark, Patrick Cantlay and Rickie Fowler, who had to play the final eight holes in even par to post an 82.

**Anshu settles for silver in Budapest**  
Budapest: Indian woman wrestler Anshu Malik could not match the skills of her 21-year-old Chinese rival Kexin Hong in the final, bowing out tamerly to settle for a silver in the 57kg category of the Budapest Ranking Series here. Competing against the No.1 ranked Chinese, Anshu lost 1-12 on technical superiority against the Hangzhou Asian Games bronze medalist in the 53kg category. India's Antim Panghal had earlier fought hard to settle for a silver in the 53kg category, while star wrestler Vinesh Phogat lost to Jiang Zhu of China 0-5 in the quarterfinals in the 50kg category. Anshu started with an incredible bout against Anastasia Nichita of Moldova, winning 6-5 on points to secure a place in the semifinal. With Nichita leading 5-4 and just 19 seconds remaining on the clock, Anshu scored a takedown on the edge to claim a 6-5 lead to win the close contest. She then overcame the challenge of world champion Zhang Qi 2-1 on point to secure a title showdown with another Chinese. But Hong proved far too superior for the Indian, taking a 4-1 lead in the opening round before asserting her class in the second round and taking an unassailable lead with 11 seconds still remaining on the clock.

**Aditi lies Tied-51st at LPGA Classic**  
Galloway (USA): Aditi Ashok shot a modest 2-under 69 and was lying T-51 after the first round at the ShopRite LPGA Classic. Aditi, who has been having an average season, had four birdies in the first 10 holes but dropped two shots thereafter. Thailand's Archipaya Yubol, who had a chance to shoot a 59, carded 61. She began her opening round on the second nine at Seaview's Bay Course.

## Punjab FC clinch Dream Sports U-17 title

Punjab FC secured the Dream Sports Championship trophy with a 1-0 victory over East Bengal FC in the final at the Cooperage Football Ground in Mumbai on Friday. A solitary goal by Arshvir Singh was enough for Punjab FC, who are now the inaugural winners of the U17 club football tournament.

Both sides almost found the net on multiple occasions but lacked a finishing touch. The championship's top goalscorer Debojit Roy saw his shot for EBFC saved by goalkeeper Vishwajeet Yadav in the 21st minute. He was denied once again in the 27th minute after failing to collect Gurraj



Singh Grewal's lofted ball, ending a promising attack. In the first minute of the first half injury time, midfielder Arshvir found the net courtesy of an excellent shot from outside the penalty box. It was a moment of brilliance

for Punjab FC, with the shot beating East Bengal goalkeeper Deep Barman. With a narrow lead, Punjab FC upped the ante in the second half. They pressed their opponents well and won the ball in key areas of the pitch.

“It is an overwhelming feeling for me personally to score in a final for the first time in my life. I am very proud of my boys, the team played very well. Getting the limelight in such major tournaments that are broadcast all over India, is very helpful for youth like me to gain experience. But winning it is a great feeling.”

## PRAGG BEATS NAKAMURA

PTI / STAVANGER (NORWAY)

Indian Grandmaster R Praggnanandhaa ended his campaign on a positive note by defeating American Hikaru Nakamura in the finale to sign off third even as world number one Magnus Carlsen won the Norway Chess tournament here.

Carlsen walked away with prize money of 7,00,000 NOK (Around USD 65,000 reserved for the winner) for ending with 17.5 points in the unique tournament that ensured that each round had a winner either through Classical time control or Armageddon if the

game ended in a draw. Nakamura finished second on 15.5 points despite losing to Praggnanandhaa, who concluded third on 14.5 points. Praggnanandhaa can be happy with the fact that he defeated the top three ranked players in the world in one of the strongest ever tournaments. He had beaten Carlsen and Caruana under Classical time control earlier in the tournament and his win against Nakamura ensured that he became the first player ever to beat the top three. The fourth place went to Alireza Firouzja (13.5 points).
