- 1) The above results were reviewed and recommended by the Audit Committee at its meeting held on May 26, 2023 and were placed and approved at the meeting of the Board of Directors held on May 26, 2023
- 2) The company operates in the segment of Systems Integration and Services
- 3) Figures for the quarter ended March 31, 2023 and March 31, 2022 pertaining to the Company are the balancing figures between audited figures in respect of the full financial year and published year to date unaudited figures up to the third quarter of the year ended March 31, 2023 and March 31, 2022 for the Company.
- 4) These statements have been prepared in accordance with Companies (Indian Accounting Standards) Rules 2015 (Ind AS) prescribed under Section 133 of the Companies Act, 2013 and pursuant to the requirements of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and other accounting practices and policies to the extent applicable.
- 5) As on March 31, 2023, the Company had allotted 9,60,000 equity shares and 4,55,000 equity shares for Rs. 28 each (including premium of Rs. 18 each) on conversion of warrants into equity shares on September 01, 2022 and September 24, 2022 respectively. Further, the total proceeds of Rs. 2.97 crores received on the said allotments were utilized by the Company as on September 30, 2022, towards the objects as stated in the Explanatory Statement of the Notice of the Annual General Meeting of the Company dated September 03, 2020.
- 6) The Statutory Auditors of the Company have carried out the audit and have issued their unmodified opinion on the financial statements.
- 7) The Company had announced the Dynacons - Employees Stock Option Plan 2020 (ESOP – 2020) which provided for the grant of equity shares of the Company to the eligible employees of the Company. Under ESOP 2020, the Company had approved grant of 33,500 options vide its Nomination and Remuneration committee meeting held on August 10, 2022.
- 8) The previous years have been restated wherever necessary.
- 9) An interim dividend of Rs. 0.50 per share of the Nominal value of Rs. 10/- each was declared on August 10, 2022 and paid to all the eligible shareholders on August 23, 2022.

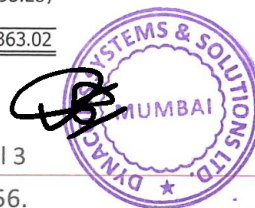
