Subject: Intimation regarding Order of the Hon'ble National Green Tribunal (NGT) under Reg. 30 of SEBI (LODR) Regulation, 2015

Dear Sir/Ma'am,

Pursuant to the provisions of Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with other related circulars in this behalf, we would like to bring to your kind notice that the Punjab Pollution Control Board (PPCB) vide its communication dated 18th August, 2023, decided to revoke the consent to operate granted by it to Patiala Plant of the Company. As the Company had already taken the remedial measures on the observations of PPCB, the Company approached the Hon'ble NGT against the said communication of PPCB. The Hon'ble NGT has allowed the continuation of operations of the Patiala Plant until the next date of hearing.

The details of the matter are as follows: -

i. Name of the authorities: - PPCB/ NGT

ii. Nature and details of the action(s) taken, initiated or order(s) passed: - the Company is required to deposit environment compensation of Rs. 50 Lakhs and a Bank Guarantee of Rs. 1 Crore in favour of PPCB.

iii. Date of receipt of direction or order, including any ad-interim or interim orders, or any other communication from the authority: - The Order dated 29th August, 2023 of NGT (uploaded on NGT's website on 30th August, 2023).

iv. Details of the violation(s)/ contravention(s) committed or alleged to be committed: - The Punjab Pollution Control Board (PPCB) vide its communication dated 18th August, 2023 had made certain observations under the Air (Prevention and Control of Pollution) Act and Water (Prevention and Control of Pollution) Act. The same had been rectified immediately thereafter.

v. impact on financial, operation or other activities of the listed entity, quantifiable in monetary terms to the extent possible: - Rs. 50 Lakhs being the amount of environment compensation.
