The trade receivables in the books of ISL India represents services performed and billed on ISNA over the years in respect of offshore services for the clients of ISNA. The Management is working on turning around the business performance of ISNA and are hopeful of generating profits to pay ISL India against the trade receivables and to this effect have drawn up business plans for the subsidiary for the next few years. In view of the above, the Management considers not making any provision towards any expected credit loss against these Accounts Receivable from ISNA including GST liability if any on such export receivables together with interest thereon as we are hopeful of collecting the dues from ISNA. This is a subject matter of qualification in the standalone limited review report for the quarter ended 30 June 2020, 30 September 2020 and 31 December 2020 and year ended 31 March 2020 and in the consolidated limited review report for the quarter ended 30 September 2020, 31 December 2020 and period ended 31 December 2020.
