Leading Precision Component Manufacturer Gala Precision Engineering files DRHP for IPO

Mumbai-based Gala Precision Engineering Limited, a leading precision component manufacturer of technical springs, has filed its Draft Red Herring Prospectus (DRHP) with capital market regulator Sebi to raise funds for its initial public offering (IPO).

The IPO has a face value of Rs 10 and consists of a fresh issue of equity shares up to 25.58 lakh and an offer for sale up to 6.16 lakh equity shares by the Promoter Group and Individual Selling Shareholders. The offer includes a reservation for subscription by eligible employees. The offer for sale consists of the sale of equity shares of up to 385,200 by Vishanji Harshi Gala, up to 58,600 equity shares by Kirit Vishanji Gala (HUF), up to 50,000 equity shares by Nayna Gala, up to 40,000 equity shares by Satish Kotwani, up to 31,400 equity shares by Hemlata Dhiraj Shah, up to 28,000 equity shares by Dhiraj Nanchand Shah, up to 12,800 equity shares by Urmil Dhiraj Shah, and up to 10,000 equity shares by Rupa Sunil Mehta. The Offer is

being made through the book-building process, wherein not more than 50% of the offer shall be available for allocation on a proportionate basis to qualified institutional buyers, not less than 15% of the offer shall be available for allocation to non-institutional bidders, and not less than 35% of the offer shall be available for allocation to retail individual bidders.

Child murdered in Kanaipur, police begins probe

Hooghly : An eight-year-old child was brutally murdered at Adarsh Nagar English Road area of Kanaipur Gram Panchayat of Hooghly district in West Bengal on Friday evening. According to local sources, the class four student Snehanshu Sharma was doing homework in his room on Friday evening. Snehanshu's father Pankaj Sharma works in a private company in Kolkata and mother Guddi Sharma also works in a cosmetic shop. In the evening Snehanshu was studying at home. Meanwhile, when his cousin sister living in the

neighborhood entered his room, she found Snehanshu lying in a pool of blood. Hearing her screams, the locals gathered and informed the police. Everyone was surprised to see the scene inside the room. The TV was playing loudly and Snehanshu was lying soaked in blood. There were several deep wounds his body. Snehanshu was immediately taken to a private hospital in Hindimotor where doctors declared him brought dead. According to police sources, when they reached the spot, they saw that the entire room was covered in blood. There were several injury

marks all over the child's body. His head was badly injured. The police took the body in their custody and sent it for post-mortem. The Police Commissioner of Chandannagar Police Commissionerate, Amit P Javalgi, arrived to inspect the incident site on Saturday, said that the help of forensic experts will be taken to investigate the matter. The killers will be nabbed soon. When Hindusthan Samachar team went to the spot and investigated, they found that Snehanshu's family has a pet dog in thier house and it barks whenever outsiders

come. But at the time of the incident no one even heard the barking sound of that pet dog. The English Road area of Adarshnagar is densely populated. It is primarily believed that someone known to the family may be behind this murder.
