# India, EU decide to expand...

India and the 27-nation European Union on Wednesday decided to set up a high-level dialogue to enhance trade and investment on moving towards a more circular economic model.

Reflecting growing convergence in ties, the two sides also unveiled a five-year partnership agreement, further boosting their strategic partnership, announced institution of a separate maritime dialogue and released a declaration on moving towards a more circular economic model.

Launched in June 2007, negotiations for the proposed Broad-based Trade and Investment Agreement (BITA) have witnessed many hurdles as both sides have major differences on crucial issues. The negotiations on the pact has been stalled since 2015.

KOLKATA: BCCI President Sourav Ganguly on Wednesday was forced to go into home quarantine after his elder brother and Cricket Association of Bengal (CAB) Joint Secretary Snehasish Ganguly tested positive for Covid-19.

## Pilot's Start-up falters...

"We have proof of horse-trading: Rs 30 crore was offered. Those who took the money are hooked up at the hotel in Manipal. Our deputy chief minister and PCC chief (Pilot) himself was negotiating the deal and, at the same time, giving statements that no horse-trading was on. What clarifications are you giving when you yourself were involved in it?" Gehlot charged. Sources said Gehlot was misled when AICC general secretary K K Venugopal conveyed a message from the Gandhi family asking him to bury the hatchet.
