With reference to the above, we would like to inform you that the IND AS provisions is applicable to Margo Finance Limited being NBFC from Financial Year 2019-20.

Though, pursuant to Regulation 33(3) of SEBI (LODR) Regulations, 2015, the listed entity shall submit Quarterly& half Yearly Financial Results to the stock exchanges within 45 days of the end of each quarter, in order to facilitate smooth transition during the first year of IND-AS implementation, SEBI vide its Circular no. CIR/CFD/FAC/62/2016 dated 05/07/2016 has granted extension of one month i.e. upto 14<sup>th</sup> September, 2019 and upto 14<sup>th</sup> December 2019 for submitting the Unaudited Financial Results for the Quarter Ended 30th June, 2019 and quarter ending 30<sup>th</sup> September 2019 respectively to the stock exchanges by the listed entities to which the IND-AS Rules became applicable. We refer to point 2.7 of said circular.

In view of the captioned extension granted by above mentioned SEBI Circular, it is proposed to convene and hold the meeting of the Board of Directors of the Company on or before 14<sup>th</sup> day of December, 2019 to approve the Unaudited Financial Results for the Quarter and half year ended 30<sup>th</sup>September, 2019. The actual date of the meeting will be intimated to the exchange within the due course of time.
