Corruption case against Deshmukh: Param Bir Singh moves Bombay HC to challenge panel's summons

MUMBAI, AUG 4 /-/- Senior IPS officer Param Bir Singh filed a petition in the Bombay High Court today challenging an order issued by a one-member inquiry commission, set up by the Maharashtra government to probe into allegations of corruption against former state home minister Anil Deshmukh, directing the former Mumbai police commissioner to appear before it for deposition.

Singh in his petition also challenged the legality of the commission's inquiry on the ground that the scope entrusted to the

commission has already been adjudicated by the High Court and the Supreme Court.

In the petition, Singh demanded the HC to declare that the scope entrusted upon the inquiry commission stands adjudicated and therefore, nothing survives to be inquired into by the commission. The IPS officer also sought for interim reliefs by way of staying the proceedings before the commission and the summons issued to him to appear before it on August 6. The Maharashtra government on March 30 this year constituted a one-member high level inquiry commission headed by former Justice K U Chandival to probe into allegations of corruption and misconduct levelled against the then state former home minister and NCP leader Anil Deshmukh. Singh in his petition stated that the commission had to inquire and submit its findings on whether any offence was made out against Deshmukh, as alleged by Singh in his letter to the Maharashtra chief minister on March 20, 2021.

The IPS officer claimed that the high court, in its judgement dismissing a petition filed by Deshmukh seeking to quash the CBI FIR lodged against him, noted that a prima facie cognisable offence was made out against the NCP leader.

The petition further said even the order passed on April 5, 2021 by the High Court, directing the CBI to carry out a preliminary enquiry against Deshmukh, noted that serious allegations were levelled against him. The April 5 order of the High Court was challenged in the Supreme Court by the state government and Anil Deshmukh.

The Supreme Court while refusing to intervene was pleased to observe that the nature of allegations, the personas involved and the seriousness of the allegations do require an independent agency to enquire into the matter and that it was a matter of public confidence, Singh said in the petition.

Union health minister speaks to Kerala CM over COVID situation

NEW DELHI, AUG 4 /-/- Union health minister Mansukh Mandaviya today spoke to Kerala chief minister Pinarayi Vijayan over rising coronavirus cases in the state and sought his cooperation in managing the situation.

Kerala has been witnessing a surge in the cases, with 49.85 per cent of the total COVID-19 cases in the country being reported from the southern state. "The Central Government's team headed by NCDC has returned from Kerala & submitted its report. I have spoken with the Chief Minister of Kerala, @VijayanPinarayi ji, over the phone and discussed the matter of the rising #COVID19 cases in the State," Mandaviya tweeted.

"I have also written a letter to CM Vijayan Pinarayi ji for taking more proactive measures and precautions to control the ongoing situation in Kerala. I have sought the State's cooperation in managing the situation and have assured Central Government's complete support," he said in another tweet. The Centre had sent a six-member team to Kerala and it had shared some of the observations with the state on the overall management of the situation.

Kerala had on Tuesday reported 23,676 fresh COVID cases, pushing the total infection count to 34.49 lakh, with the number of people succumbing to the virus touched 17,103 after 148 additional deaths, officials said. (PTI)

Kerala HC extends interim protection from arrest to 3 former cops, ex-IB official in ISRO conspiracy case

KOCHI, AUG 4 /-/- The Kerala High Court today extended by a week the interim protection from arrest given to three former Kerala Police officers and a retired IB official in the ISRO conspiracy case. Justice Ashok Menon extended the relief for a week after the counsel for CBI told the court that an additional solicitor general would be appearing in the matter. The court then listed the matter for hearing on August 5. The High Court had on separate dates granted interim protection from arrest to former Kerala Police officers -- R B Sreekumar, S Vijayan and Thampi S Durga Dutt -- and ex-Intelligence Bureau (IB) officer P S Jayaprakash who all have moved pleas for anticipatory bail in the case registered by CBI.

Besides these four, 14 others are named as accused in the case registered by the agency for various offences, including criminal conspiracy, kidnapping and fabrication of evidence, under the Indian Penal Code, in connection with the arrest and detention of former ISRO scientist Nambi Narayanan in the 1994 espionage case. Besides Narayanan, two Maldivian women -- Mariyam Rasheeda and

Fouziyya Hassan -- were also arrested and detained in the 1994 case. The two women were jailed for more than three years before they were released. Advocate Prasad Gandhi, appearing for the two women, contended that the accused should not be granted any relief as the Maldivian nationals were harassed, unfairly arrested, and detained for over three years by the officers who investigated the spy case.

The counsel for the accused said the alleged conspiracy happened over 25 years ago and therefore, there was no need for the CBI to drag on the anticipatory bail pleas.

The court said that the accused were sufficiently protected from arrest by an interim order and therefore, they should not be concerned if the matter takes time as it has huge ramifications. (PTI)
