New Delhi: The Centre is considering enhancing the outlay for its flagship rural employment guarantee scheme by ₹15,000 crore.

The government has already exhausted about ₹37,500 crore provided for the Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) till July, which is more than 50% of the total budgeted allocation.

Officials told ET that the scheme may require 20% additional funds over and above the budgeted allocation of ₹73,000 crore for 2022-23. The Centre had allocated ₹73,000 crore in financial year 2021-22 also but it was later revised to ₹98,000 crore, though actual spending on the scheme shot up to ₹1,06,548.18 crore.

"The scheme may require another ₹15,000 crore in the second half," an official told ET on condition of anonymity, adding that if required, the Centre may seek a supplementary demand during the winter session of Parliament.

states have indicated that the demand is likely to be higher in August and September. The government has pegged its labour budget or person days work to be generated under MGNREGS at ₹227.6 crore for 2022-23.

Work demand under the scheme has remained elevated with 31.6 million households demanding work in June compared to 30.7 million in May. July, which is considered a lean month because of the monsoon, saw 20.4 million households demanding work.

A rural development ministry official said there was increasing pressure from states for clearing of pending dues and enhancing allocation. Apart from West Bengal and

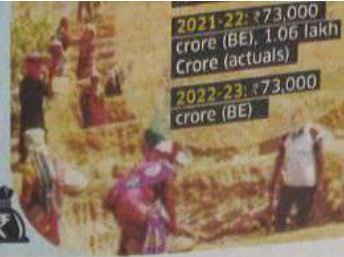

Telangana, BJP-ruled states such as Bihar, Uttar Pradesh, Karnataka and Madhya Pradesh have also approached the Centre seeking release of pending dues.

As on July 27, the pending liabilities for the wage component under

the scheme stood at ₹5,517.87 crore, with West Bengal claiming ₹2,636.71 crore, Bihar ₹1,160.77 crore and Uttar Pradesh Rs 661.42 crore, the rural development ministry had informed Parliament. The pending liabilities for mate-

States have requested the Centre to relax certain conditions imposed earlier this fiscal for release of funds. The Centre has mandated that workers' attendance be captured only through the National Mobile Monitoring System app for all the worksites wherein muster rolls are issued for 20 or more beneficiaries. This was done following reports of fake attendance claims to get wages. States, however, claim that this was leading to issues in areas with low connectivity.

The Centre has also directed that simultaneous works in a panchayat be restricted to 20, with effect from August 1.
