Amit has built a career in financial services and since 2015 has co-founded 3 financial advisory firms. Amit is founder and director of VT Investment Advisers ("Valtrust Capital") a multi-family office; founder, director and investment committee member of SC India Advisors Private Limited – a SEBI registered AIF Category 2 Manager (corpus c.
