MOSCOW | Putin says arming Ukraine would be 'a big mistake'

Russia warns S Korea

Agencies HANOI

Russian president Vladimir Putin has warned South Korea it would be making "a big mistake" if it arms Ukraine in the war against Russia.

His comments come after Seoul said it was considering such a possibility, in response to Russia and North Korea's new pact to help each other in the event of "aggression" against either country.

Moscow "will... [make] decisions which are unlikely to please the current leadership

of South Korea" if Seoul decides to supply arms to Kyiv, Putin said on Thursday. The Russian leader was speaking in Vietnam, shortly after a visit to Pyongyang where he signed a mutual defence agreement with North Korean leader Kim Jong Un.

Putin also warned that Moscow is willing to arm Pyongyang if the US and its allies continue supplying Ukraine with weapons.

"Those who supply these weapons believe that they are not at war with us. I said, including in Pyongyang, that we then reserve the right to supply weapons to other regions of the world," Mr Putin said.

Strikes on Gaza Strip, Rafah stepped up

US, China hold first nuclear talks in 5 yrs

Israeli forces pounded Rafah and other areas across the Gaza Strip and engaged in close-quarter combat with fighters led by Palestinian Islamist group Hamas, residents and Israel's military said.

Residents said the Israelis appeared to be trying to complete their capture of Rafah; the city has been the focus of an Israeli assault since May. Tanks were forcing their way into the western and northern parts of the city, having already captured the east, south and centre. Israeli forces fired from planes, tanks and ships off the coast, forcing a new wave of displacement from the city, which had been sheltering more than a million displaced people, most of whom have been forced to flee again. The Israeli military said on Friday its forces were conducting "precise, intelligence-based" actions in the Rafah area, where troops were involved in close-quarter combat and had located tunnels used by militants.

HONG KONG: The United States and China resumed semi-official nuclear arms talks started in

March for the first time in five years with Beijing's representatives telling the US counterparts that they would not resort to atomic threats over Taiwan, according to two American delegates who attended.

The Chinese representatives offered reassurances after their US interlocutors raised concerns that China might use, or threaten to use, nuclear weapons if it faced defeat in a conflict over Taiwan.

Forest fire kills 5

Five people were killed and 44 were injured after a fire that apparently started in crop stubble spread through settlements in southeast Turkey overnight, officials said on Friday. The blaze erupted in an area between Diyarbakir and Mardin. It moved quickly through the villages of Koksalan, Yaz-cicegi and Bagacki, Diyarbakir Governor Ali Ihsan Su said. The fire was brought under control early on Friday. Health Minister Fahrettin Koca wrote on X that 44 people were treated in hospitals, including 10 who were in serious condition.

5.7 quake hits Indonesia

A 5.7-magnitude earthquake jolted off Indonesia's Highland Papua province on Friday without generating large waves, the country's meteorology, climatology and geophysics agency said. The tremors occurred at 7:11am local time, with the epicentre located 68 km northeast of Yalimo Regency and at a depth of 78 km beneath the earth's surface. No tsunami warning was issued and there were no reports of any casualties.

2 die in clash with cops

Two people were killed on when locals protesting alleged water contamination by a pork processing plant clashed with police in Mexico. Residents of San Antonio Limon were blocking a road demanding government action against the operation, which they said was responsible for polluting the aquifer and using too much water. Protesters said police began beating them and opened fire. Brothers Alberto and Jorge Cortina Vázquez were killed, according to the state prosecutor's office.

Lynched over blasphemy

A Muslim mob in northwestern Pakistan on Thursday broke into a police station, snatched a man who was held there and then lynched him over allegations that he had desecrated Islam's holy book, the Quran. The attackers also torched the station in Madyan, in Khyber Pakhtunkhwa province, and burned police vehicles parked there, according to local police official Rahim Ullah. The slain man, Mohammad Ismail, was a tourist who was staying at a hotel in the town when some locals turned on him and accused him of blasphemy. Ullah said police officers took the man to the station for his protection but the mob swelled and pursued them. The mob then attacked the station, snatched Ismail, beat him to death and then burned his body and left it on the road.
