साम आणि मिझोराम यांच्यातील सीमावादाला सोमवारी (ता. २६) हिंसाचाराचे गालबोट मिझोराममधील समाजकंटकांनी केलेल्या गोळीबारात आसामच्या सहा पोलिस अधिकाऱ्यांचा मृत्यू झाला. या घटनेवरून आसामाचे मुख्यमंत्री हिमंता बिस्व सरमा यांनी आणि मिझोरामचे मुख्यमंत्री झोरामथंगा यांच्यातही द्विटरवरून शाब्दिक युद्ध रंगले. सीमाप्रश्नावरून दोन राज्यांतील हिंसाचार आणि दोन मुख्यमंत्र्यांचा वादानंतर संपूर्ण देशाचे लक्ष पूर्वेकडील या राज्यांकडे गेले. मात्र हा वाद नवा नसून १०० वर्षे जुना आहे. ब्रिटिश काळात मिझोरामला आसामचे लुशाई हिल्स नावाने ओळखले जात असे.

इतिहासात वादाची बीजे

स्वातंत्र्याच्या वेळी आसाम व मणिपूर व त्रिपुरा ही संस्थानिक राज्य मिळून ईशान्य भारत तयार झाला. नागालँड, मेघालय, अरुणाचल प्रदेश आणि मिझोराम ही राज्ये १९६३ ते १९८७ या काळात आसाममधून वेगळी झाली. इतिहास आणि रहिवाशांच्या सांस्कृतिक परंपरा लक्षात घेऊन या राज्यांची निर्मिती झाली. आसाम व मिझोराममध्ये १६५ किलोमीटरची सीमा आहे. सीमेवर मिझोरामच्या हद्दीतील ऐझॉल, कोलाशिब आणि मामीत हे जिल्हे आहेत तर आसामच्या भागात कचर, करिमगंज आणि हैलाकंडी हे जिल्हे येतात. ब्रिटिशांनी लुशाई हिल्स (मिझोराम) आणि कचहर हिल्स (आसाम) अशी हद आखली. याविषयीची अधिसूचना १८७३मध्ये प्रसिद्ध झाली होती. याच काळात 'बेंगाल ईस्टर्न फ्रंटियर रेग्युलेशन' (बीईएफआर) तयार करण्यात आले.

हे नियम म्हणजेच अंतर्गत प्रवेश नियम किंवा अंतर्गत प्रवेश परवाना (इनर लाइन परमीट) आहे. कालांतराने आसाम व ईशान्येकडील अन्य राज्यांमधून 'बीईएफआर' हटविण्यात आला. मात्र मिझोराम व नागालँडमध्ये त्याची अंमलबजावणी सुरूच राहिली. १९९३मधील लुसाई हिल्सच्या अंतर्गत प्रवेश परवाना अधिसूचनेला मिझोरामचा पाठिंबा होता. पण आसामबरोबर हद्द निश्चिती करण्याचा त्यांचा आग्रह होता. १८७३च्या कायद्यानुसार सुमारे एक हजार ३१८ चौरस किलोमीटर एवढा भूभागावरील राखीव जंगलावर हक्काचा दावा मिझोरामने केला. १४८ वर्षांपूर्वीच्या या नियमाचे पालन करीत या जागेवरील हक्क सोडण्यास आसामने नकार दिला. तेव्हापासून आतापर्यंत हा सीमावाद सुटलेला नाही.
