ICAD Team performs coronary artery bypass grafting on beating heart at SIMS Hospitals

Chennai, Aug 11: ICAD (Institute of Cardiac and Aortic Disorders) team at SIMS Hospitals, Vadapalani successfully treated a rare cardiac cause of hoarseness of voice and breathing difficulty in a 66-year-old male (US based NRI) through multiple complex surgical interventions.
