

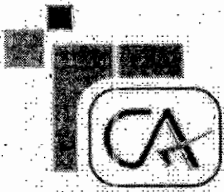

INDEPENDENT AUDITORS' REVIEW REPORT

1. 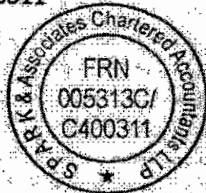
