Chairman informed that the AGM notice dated September 2, 2020 was circulated by e-mail to shareholders and hosted on the website of the Company, Stock Exchanges on September 4, 2020 and also published in The Financial Express and Samyuktha Karnataka, Newspapers on September 6, 2020.

NOTICE OF THE MEETING:

With the permission of the members he took the **Notice** convening the AGM along with the explanatory statement as read, as the same was previously circulated to the members. The Members agreed to the same.

Chairman requested Ms. Bindu Company Secretary to provide general instructions to the members regarding participation in the meeting.

Ms. Bindu D, Company Secretary informed that the 34th AGM was being held through VC/ OAVM in accordance with the circulars and Guidelines issued by MCA and SEBI. She informed that the facility for joining this meeting through VC/ OAVM was made available for the members including the facility for raising queries and that the members were provided with the facility to exercise their right to vote by electronic means, both through remote e-voting and e-voting at the AGM in accordance with the provisions of the Companies Act, 2013 and SEBI Listing Regulations.
