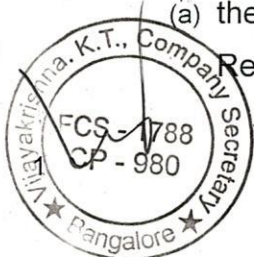
**SECRETARIAL COMPLIANCE REPORT OF

I, Vijayakrishna K T, Practising Company Secretary have conducted the review of the compliance of the applicable statutory provisions and the adherence to good corporate practices by AstraZeneca Pharma India Limited (hereinafter referred as 'the listed entity'), having CIN: L24231KA1979PLC003563 and having Registered Office at "Block N1, 12<sup>th</sup> Floor, Manyata Embassy Business Park, Rachenahalli, Outer Ring Road Bangalore-560045.
