मुहर मारकर उन्हें एकांतवास में भेज दिया। कहा गया कि अब आप बाहर नहीं निकल सकते, अनुसंधान नहीं कर सकते और किसी का बयान दर्ज नहीं कर सकते। डीजीपी ने कहा, 'इसे मैं एक तरह से हाउस अरेस्ट ही कहूंगा। जब मुझे जानकारी मिली, हम लोगों ने उन्हीं के नियम एवं प्रावधान का हवाला देते हुए कि उक्त आइपीएस अधिकारी को एकांतवास से मुक्त किए जाने को लेकर बीएमसी प्रमुख को पत्र लिखा, पर उनके जवाब का सारांश यही है कि उन्हीं एकांतवास से मुक्त नहीं किया जा सकता है।' उन्होंने कहा कि सुशांत मामले की सुनवाई के दौरान बुधवार को सुप्रीम कोर्ट ने माना कि उक्त अधिकारी को एकांतवास में रखा जाना ठीक नहीं है। पांडेय ने कहा 'हमें उम्मीद थी कि एकांतवास में रखे गए आइपीएस अधिकारी को वे छोड़ देंगे पर बुधवार की रात 11 बजे जब मैंने विनय तिवारी को फोन किया तो पता चला कि उन्हीं

नहीं छोड़ा गया है।'
