marked a turning point in the history of Ayodhya, sparking Hindu-Muslim riots and a long-drawn legal dispute that finally ended in November 2019 with the Supreme Court awarding the land to a trust for building a Ram temple.

The thread of that recent history ran through the congregation of 175 at the ground-breaking ceremony that included Uttar Pradesh governor Anandiben Patel, chief minister Yogi Adityanath, RSS chief Mohan Bhagwat, and Ram Janmabhoomi Teerth Kshetra trust head Nitya Gopal Das, who consecrated the first bricks that will go into building the temple.

Modi said that it was an emotional moment for the entire country, not only for Ayodhya, and that every heart was illuminated today.

"We will have to keep everyone's sentiments in mind. We have to ensure everyone's development with the support and trust of all. I believe this grand Ram temple to be built in Ayodhya, like the name of Shri Ram, will reflect the rich heritage of Indian culture. I believe it will inspire the entire humanity till eternity."

"The construction of the temple is not just historic, but history is repeating itself... The way Dalits, deprived, tribals and every section of the country supported Mahatma Gandhi during the freedom struggle; similarly, the entire country is standing united for the construction of the temple," Modi said.

"Ram's life is the way forward for Gandhi's Ram Rajya. When we move forward, the country will move forward. This Ram temple will inspire and guide us for ages," the prime minister added.

Panel may scrutinize govt plans for migrant workers

₹20 tn package, housing scheme for poor could be on parliamentary body's agenda

The parliamentary panel on labour is likely to scrutinize the decisions taken by the National Democratic Alliance (NDA) earlier this year during the nationwide lockdown to benefit migrant workers who started walking back to their villages from urban centres.

The reverse migration of workers witnessed during the lockdown is expected to be taken up for debate during Parliament's upcoming monsoon session.

Parliamentarians are expected to raise questions when the standing committee on labour is scheduled to meet on 7 August on the ₹20 trillion package announced by the Union government and the housing scheme for financially weaker sections in urban and rural areas.

The Centre on 16 May announced the distribution of free foodgrain and pulses to 80 million migrant labourers not covered under the National Food Security Act or public distribution system at 5kg per person per month for two months. It also announced an affordable housing scheme expected to benefit about 300,000 workers initially, according to the ministry of housing and urban affairs.

The panel will hold two meetings and has invited representatives of the ministries of urban development, rural development, skill development and entrepreneurship and consumer affairs, and food and public distribution.

and preparedness of each ministry after the announcement made by Prime Minister Narendra Modi. We want to understand the Garib Kalyan Yojana scheme and also the progress of housing for the poor in cities and rural areas," said senior member of the committee, who did

not want to be named. Committee members also said they would try to understand the preparations, especially as minister for consumer affairs, food and public distribution Ram Vilas Paswan

had blamed states for the delay in providing foodgrain to financially weaker sections.

"The Union government had announced free food supply during the nationwide lockdown and later extended it for a few months, so we want to understand the progress and

concerned, the most crucial topic is migrant workers and their plight. After the submission of a draft report on social security code, the focus of the committee is on what the government is doing with respect to provisions particularly related to interstate migrant workers," another member of the committee said, requesting anonymity.

Last week, the labour committee had batted for unorganized sector workers and proposed a blueprint for the Centre to include gig economy workers, while acknowledging rapid changes in the labour market in the report for Code On Social Security, 2019.

The Supreme Court on Wednesday referred to a five-judge Constitution bench a batch of petitions chal-

lenging the validity of an amendment seeking to reserve 10% of government jobs and places in educational institutions for economically weaker sections (EWS).

The reference order was passed by a bench headed by Chief Justice S.A. Bobde. The top court had reserved the order on 31 July 2019.

The government, while passing this amendment, had held that it would not affect reservations for other groups.

The petitions have been filed by non-governmental organizations and individuals who have challenged the amendment on the grounds that reservation based solely on someone's economic background is not valid.

SAIL's July sales up 50% to 15.83L tonnes

State-owned SAIL said its total sales grew by about 50% on year to 15.83 lakh tonnes (LT) during July 2020. The company had registered sale of 10.59 LT steel during the same month last year, Steel Authority of India Ltd (SAIL) said in a statement. "SAIL attained a sales volume of 15.83 LT in July 2020 which is its best ever performance in the month of July and an impressive growth of about 50% over July 2019 sales which was 10.59 LT," it said. The company sold 12.73 LT steel in domestic market and exported 3.10 LT steel in July, a growth of 29% and 349%, respectively, over the year-ago month. IMC organises interaction with Dr. Junaid Ahmad, Country Director, WB India

"We have entered into a world of extreme events," said Dr. Junaid Ahmad, World Bank Country Head for India while speaking to the members of managing committee on how to Reboot, Reform and Resurge Indian economy. Elaborating on it, he said how government deals with them will depend on how private sector engages with the state to enhance its capability, create institutions and systems which are resilient. Dr. Ahmad sees the Indian economy coming back with a gradual growth of 4 to 5 percent in next two years and with the kind of sectoral reforms that the government is taking and if it continues on that path, the goal of 7 percent is not unrealistic. The IMC's Engage Maharashtra mission this year is initiated with the same view to take state-private sector partnership beyond just PPP, said Rajiv Podar, President, IMC in his concluding remarks.

SER's RPF commendable performance amid lockdown

South Eastern Railway (SER) RPF (Railway Protection Force) personnel has played a significant role in providing security of rail travellers as well as in guarding the railway property and its vital installations. During lockdown, in the wake of COVID-19 pandemic, RPF personnel of this railway has conducted surprise drives and has imposed and realised fine and recovered railway property and other valuable goods worth Rs. 85.66 lakh during the period from 1st April to 30th June, 2020.
