'लगौटी स्कूल में शिक्षकों के पद जल्द भरे सरकार'

कुल्लू जिले के शिक्षा खंड आनी के दुर्गम क्षेत्र के रेंड माध्यमिक विद्यालय लगौटी में प्रधानाचार्य सहित शकों के कई पद खाली चल रहे हैं जिसके चलते हल से बच्चों को पलायन करने पर मजबूर होना पड़ ग है। इसे लेकर अब गुस्साए अविभायकों और हल प्रबंधन समिति ने प्रदेश सरकार को एसडीएम जी के माध्यम से भेजे एक पत्र में चेताना दी है ; यदि दो जुलाई तक स्कूल में शिक्षकों के रिक्त पदों 1 न भरा गया तो तीन जुलाई को निगाम में राष्ट्रीय नमार्ग 305 में सुवह 9 बजे से अनिश्चित काल के ए चक्का जाम कर दिया जाएगा।

स्कूल प्रबंधन समिति के प्रधान परस राम चौहान बताया कि वरिष्ठ माध्यमिक स्कूल लगौटी में रिक्त
