President Murmu confers degrees to students at Doon University convocation

Dehradun, Dec 12: The President of India, Droupadi Murmu graded and addressed the 3rd convocation of Doon University in Dehradun recently wherein she conferred degrees to 669 students and gold medals to 36 scholars.

Speaking on the occasion, the President said that the advancement of any country depends on the quality of its human resource and the quality of human resources depends on the quality of education. She advised Doon University to work towards creating quality human resources, adopting the dictum 'today's youth is tomorrow's future'. Educationists should encourage research and innovation, she stressed.



The President noted that the Centre for Public Policy Chair has been set up at Doon University in collaboration with NTPC which is devoted to policy-making and capacity-building for the development of the State. She also said that research and innovation should be stimulated in educational institutions so that students could be more fortified with technical skills and provide employment to others instead of seeking employment for them.

The President appreciated that Doon University is the only premier institution in the state where students are taught five foreign languages – Chinese, Spanish, German, Japanese, and French. Students can also study Garhwali, Kumaoni, and Jaunsari, here three local cherishable languages she said that encouraging the study of local languages is an admirable step in conserving our folk culture. Folk languages are the imperceptible heritage of our culture. University should take forward this initiative.

Pointing to the fact that in today's convocation girls got 23 gold medals out of 36 and 8 Ph.D. degrees out of 16, the President said that this proves that there are adequate chances for the education of women in Doon University and the University is dedicated to encouraging girls. She said that, in her view, when girls shine more in subjects like Science, Technology, Engineering, and Mathematics (STEM), the process of women empowerment would be further strengthened.

Minister Shri Pushkar Singh Dhami said that students should emulate the President as an inspiration for simplicity and conscious struggle which made her rise to the pedestal of the Presidency of the world's largest democratic country. He added that Uttarakhand, a Dev Bhoomi is a divine land of impeccable fervor of religion, spirituality, and culture that are being nurtured from time immemorial.

The Education Minister Dr. Dhan Singh Rawat while congratulating the students stressed that Uttarakhand is the first state in the country in implementing a New Education Policy. Eminent space scientist Dr. Kasthurirangan said that New Education Policy fulfills the aspirations

and dreams of the 21st-century youth which is the core vision of our Prime Minister. He appreciated the initiatives undertaken by Doon University.

Vice Chancellor Prof Surekha Dangwal elucidated the phenomenal growth of the university which made a humble beginning a decade plus back. Graduation is a milestone in one's career for which she appreciated both the students and their parents.

Cabinet Ministers Premchand Aggarwal, Subodhuniyal, Former Chief Minister Trivendra Singh Rawat, MLAs, Vice Chancellors of Various Universities, and eminent academicians were present. Prof Purohit Professor & HOD Compered the entire convocation proceedings.

Loyola College honours rank holders with gold medals at 94th Graduation

Chennai, Dec 12: The 94th Graduation Day of the Loyola College held at its campus. Delivering the convocation address, the chief guest, Prof. Dr. M. Krishnan, Vice Chancellor, Central University of Tamil Nadu said that despite the substantial research output that we have in India, we are not recognized in global ranking of higher education. Therefore, we have to convert the fruits of the innovation and excellence

to the utility of the part of society that is found wanting and lacking. He further added that the graduating students are expected to transfer the classroom knowledge to daily life. He insisted that the students at higher education level should aim at skill enhancement, collaboration, innovation, inclusiveness and sustainability and make sure that they reach the needy with concrete societal action. Indian Knowledge System (IKS) should be opera-

tional in terms of development of the society. Of 4389 students who have passed out, 2579 students became eligible to receive their degree. During the graduation ceremony, the chief guest distributed the degree certificates to 62 gold medallists and meritorious students. Among 1933 UG, 539 PG, 47 M.Phil students who have passed out during the academic year 2020-2021, 710 students are employed, 76 are self-employed and 926

graduates are pursuing their higher studies. The other dignitaries who were part of the Graduation ceremony are Rev. Dr. Francis P. Xavier SJ, Rector, Rev. Dr. B. Jeyaraj, SJ, Secretary, Rev. Dr. A. Thomas, SJ, Principal, Dr. J.A. Charles, Deputy Principal, Rev. Dr. A. Louie Albert, SJ, Controller of Examinations and Heads of various departments.

Chennai doctor performs live complex angioplasty procedure

Chennai, Dec 12: Promed Hospital, a multispecialty hospital at Kottivakkam, Chennai, hosted the first edition of APCTO Cinema 2022 in Chennai, India. The Asia Pacific Chronic Total Occlusion Club (APCTO Club) organised the APCTO Cinema 2022, a live CTO procedure session to educate cardiologists across the globe on CTO PCI with an emphasis on safety, and had invited its director from India, Dr Arun Kalyanasundaram, to perform a procedure at this event.

Dr. Arun Kalyanasundaram, an eminent interventional cardiologist and Director of Promed Hospital, Chennai, specializing in complex Coronary Interventions and Chronic Total Occlusion (CTO) performed a complex angioplasty of a completely blocked (CTO) LAD on a patient from Chennai, India. The patient also had the critical disease in other vessels which were treated by angioplasty by Dr. Arun. The patient was deemed high risk for bypass surgery and had chest pain with

minimal exertion. The LAD, often referred to as the 'widow maker' artery, was 100% blocked from the beginning of its course. It was tackled in a 'retrograde' manner using specialized techniques by Dr. Arun. Around 500 cardiologists around the globe witnessed the live procedure and had interactive discussions through an expert panel with Dr. Arun Kalyanasundaram on CTO intervention tips, tricks, safety, and on the wide range of challenges in the status & future directions of CTO procedures.

"The aim for having this live case streamed across continents is to educate cardiologists about chronic total occlusion PCI (the most complex type of angioplasties), and how the procedure can help improve lives. At the hands of experts, success rates are very high, and can be performed in a remarkably safe manner," said Dr Arun Kalyanasundaram, Director, APCTO Club, and Director, Promed Hospital.
