With the above Capital expenditure the total Sugarcane crush capacity will increase to 41000 TCD from 38,000 TCD, Refined Sugar (Sulphur less sugar) capacity will increase for crushing capacity of 26,500 TCD from 5000 TCD. The investments will be funded by a mix of internal generation and Debt.

The existing Sugar plants are running at optimum capacity during the season.
