Ref: SEBI Circular No. SEBI/HO/MIRSD/MIRSD_RTAMB/P/CIR/2021/655 Dated November 3, 2021 read together with SEBI Circular No. SEBI/HO/MIRSD/MIRSD_RTAMB/P/CIR/2021/687 dated December 14, 2021 (the “SEBI Circulars”)

Subject: Mandatory furnishing/updating of PAN, full KYC details and Nomination

We draw your kind attention to the above and subsequent communication sent to you for updating KYC.

Securities and Exchange Board of India (SEBI) vide the above SEBI Circulars has made it mandatory for Physical shareholders to furnish PAN, address, email address, mobile number, Bank account details and nomination details. Folios wherein any one of the said details are not available on or after 1st April, 2023, shall be frozen and shareholder will not be eligible to lodge grievances or avail service request from the RTA. We would like to mention that you can still update KYC before 1st April, 2023 failing which your folio will be frozen (become in-operative).

Further, as per the above SEBI Circulars, RTA/ Company shall refer the frozen folios to the administering authority under the Benami Transaction (Prohibitions) Act, 1988 and or Prevention of Money Laundering Act, 2002, after 31st December, 2025.

Keeping in view the above requirements, the members holding shares in physical mode are requested to submit the following documents to the RTA i.e Maheswari Datamatics Private Limited, at the earliest.
