Gurugram, January 15, 2024: SpiceJet Ltd. is pleased to announce that it has received inprinciple approval from the Bombay Stock Exchange (BSE) for the issuance of equity shares and warrants convertible into equity shares on a preferential basis. This approval marks a significant milestone for the company and paves the way for a new fund infusion of INR 2242 crore.
