Pursuant to Regulation 29(1) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, and in continuation to our prior intimation dated 27<sup>th</sup> July, 2022, regarding Board Meeting to be held on Thursday, 04<sup>th</sup> August, 2022, we wish to inform you that the said meeting has been rescheduled on Tuesday, 9<sup>th</sup> August, 2022, inter alia, to consider, approve the following items:

1. Unaudited Financial Results for the Quarter ended 30<sup>th</sup> June, 2022 (on Standalone and Consolidated basis).
2. Voluntary Delisting of equity shares of the company from National Stock Exchange of India Limited (NSE) in terms of provisions of Regulation 5 and 6 of Securities and Exchange Board of India (Delisting of Equity Shares) Regulations 2021 without giving exit option to the shareholders and also continuing the listing of the equity shares at BSE Limited, which is having nationwide trading terminals.

Further, in terms of Company's 'Code of Conduct for Prevention of Insider Trading' framed in accordance with SEBI (Prohibition of Insider Trading) Regulations, 2015 as amended from time to time and further to our earlier intimation dated 30<sup>th</sup> June, 2022 and 27<sup>th</sup> July, 2022, the closure of Trading Window for dealing in the securities of the Company by all Designated Persons (including their immediate relatives) which commenced with effect from 1<sup>st</sup> July, 2022 shall continue to remain closed till conclusion of 48 hours after the declaration of the financial results for the quarter ended on 30<sup>th</sup> June, 2022.
