

Dear Shareholders,

Notice is hereby given pursuant the provisions of Section 110 and other applicable provisions, if any, of the Companies Act, 2013 (the "Act"), read with Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014, the General Circulars No. 14/2020 dated April 8, 2020, No. 17/2020 dated April 13, 2020, No. 22/2020 dated June 15, 2020, No. 33/2020 dated September 28, 2020, No. 39/2020 dated December 31, 2020 and No.19/2021 dated December 8, 2021, 3/2022 dated May 05, 2022 and 11/2022 dated December 28, 2022 issued by the Ministry of Corporate Affairs ("MCA Circulars") and including any statutory modification or re-enactment thereof for the time being in force, and as amended from time to time, and pursuant to other applicable laws and regulations, the resolution appended below is proposed for approval of the shareholders of the Company through postal ballot by remote e-voting process ("e-voting").

Approval for Re-appointment of Mrs.Valli M Ramaswami (DIN 00036508) as Chairperson and Whole Time Director of the Company

RESOLVED THAT pursuant to the provisions of Section 196, 197, 203 read with Schedule V and other applicable provisions, if any, of the Companies Act, 2013 and the Companies (Appointment and remuneration of Managerial Personnel) Rules, 2014, Regulation 17 and other applicable regulations of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('Listing Regulations') and on the recommendation of the Nomination and remuneration Committee and approval by the Board of Directors at their meeting held on February 14, 2023, the consent of the Members of the Company be and is hereby accorded to re-appoint Mrs.Valli M Ramaswami (DIN 00036508) as Chairperson and Whole Time Director of the Company for a period of 5 years w.e.f. 12th April 2023 on the terms and conditions including remuneration, as set out hereunder:-

- 4. Minimum remuneration:** In the event of any loss or inadequacy of profits in any financial year during her tenure, the remuneration payable to the Chairperson and Whole Time Director will have to be limited to amounts specified in Part II of schedule V of the Companies Act, 2013.
