Hymavathi Reddy, a person belonging to Promoter Group of the Parent Company Vide Cr No.79 of 2019 of Jubilee Hills Police Station Hyderabad, The Company has made an application to Securities Exchange Board of India (SEBI), seeking relaxation from enforcement Regulation 33 of above and the company requested the Stock Exchanges for the waiver of the fine paid by the Company for submission of financial results under the carveout policy as the company was not able to submit the said results for the reasons beyond its control. However, the Company submitted the said results on 14th August, 2019.

(b) The listed entity has maintained proper records under the provisions of the above Regulations and Circulars/ Guidelines issued there under insofar as it appears from Our examination of those records.

(c) There were no actions taken against the listed entity/its promoters/directors/material subsidiaries either by SEBI or by Stock Exchanges (including under the Standard Operating Procedure issued by SEBI through various circulars) under the aforesaid Acts/ Regulation, /Circulars/Guidelines issued there under in so far as it appears from my examination of those records except as stated below.

NSE imposed a fine of Rs.3,80,000/- (Rupees Three Lakh Eighty Thousand Only) Delayed submission of financial results for quarter and year—ended March 31, 2019 and BSE imposed a fine of Rs. 448400/- (Four Laksh Forty Eight Thousand Four Hundred Only) for non-submission of Standalone and Consolidated Audited Financial Results for the Quarter and Financial Year ended 31st March, 2019 under SEBI circular no. SEBI/HO/CFD/CMD /CIR /P/2018/77) dated, May, 03, 2018 and paid by the Company. However, the exchanges subsequently waived the said amount.
