Chartered Accountants (CAs) and people of the trade and Industry of the city will join PM Narenda Modi from New Delhi in launching of the 'Transparent Taxation-Honoring the Honest' platform on Thursday.

CA Harsh Firoda, Chairman of CA Indore Branch, informed on Wednesday that we have shared the linked of the launch program with all members of our association. He said in the same way, members of CII, FICCI FLO and trade bodies will also join the online launch program from the city.

Prime Minister Modi will launch the platform for "Transparent Taxation - Honoring the Honest" via video conferencing. The CBDT has carried out several major tax reforms in direct taxes in the recent years.

Last year the Corporate Tax rates were reduced from 30 percent to 22 percent and for new manufacturing units, the rates were reduced to 15 percent. Dividend distribution

Tax was also abolished. The focus of the tax reforms

has been on reduction in tax rates and on simplification of direct tax laws. Several initiatives have been taken by the CBDT for bringing in efficiency and transparency in the functioning of the IT Department. This includes bringing more transparency in official communication through the newly introduced Document Identification Number (DIN) wherein every communication of the Department would carry a computer generated unique document identification number.

Similarly, to increase the ease of compliance for taxpayers, IT Department has moved forward with pre-filling of income tax returns to make compliance more convenient for individual taxpayers. Compliance norms for start ups have also been simplified. The upcoming launch of the platform for 'Transparent Taxation-Honoring the Honest' by the Prime Minister will further carry forward the journey of direct tax reforms.



The Company resumed the operations partially since 4th May, 2020 in line with the regular lockdown relaxation measures issued by Ministry of Home Affairs. During quarter ended 30th June, 2020, The Group reported revenue loss of about 30% in operating income, 40% in rental income and increase in the operating expenses of about 10%.

The figures for the quarter ended March 31, 2020 as reported in these financial results are the balancing figures between the audited figures in respect of the full financial year and the published year to date figures up to the third quarter of the relevant financial year which were only reviewed and not subjected to audit
