


## Facebook to face US pact that could cost billions

Washington, February 15

**FACEBOOK IS IN** talks with US regulators over alleged privacy violations that could force the social media giant to pay billions of dollars in a record-breaking settlement, according to two people familiar with the matter.

The US Federal Trade Commission's (FTCs) consumer-protection staff and the company are in discussions that could lead to a resolution of the agency's investigation into whether Facebook violated a 2011 settlement with the FTC,

said the people, who were not identified because the matter is ongoing.

No settlement proposal was presented to the agency earlier than the one that was sent to the agency, according to one source. Facebook commissioners have not yet agreed to any agreement with the agency. It was unclear whether the agency has discussed details with Facebook. Facebook would have to pay the case. The Washington Post reported earlier that they were talking about a multi-billion-dollar settlement.

Facebook said it was in discussions with the agency and would comment.

The FTC opened nearly a year ago on whether Facebook honored previous settlements when the company's parent, Meta, gained access to the data of about 100 million
