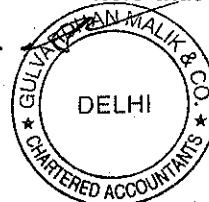

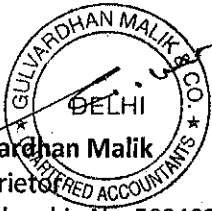
**To the Board of Directors Coral Newsprints Limited**
